FIND YOUR MOTIVATION TO QUIT SMOKING

Finding your motivation is one of the keys to becoming smoke free. Start today and begin building your list of reasons to quit. If you can't think of reasons on your own, ask your family, friends, and co-workers. They can help you find your motivation to quit.

Still need more reasons to quit? Consider these five facts about tobacco and you may be inspired.

1. Smoking is expensive

2. Smoking kills

The Campaign for Tobacco Free Kids tells us that smoking kills more people than alcohol, AIDS, car accidents, illegal drugs, murders and suicides combined. According to the American Cancer Society report, *Cancer Prevention and Early Detection Facts and Figures 2005*, approximately 87 percent of lung cancer deaths can be attributed to tobacco.



According to *The Health Consequences of Smoking, A Report of the Surgeon General*, smoking has been attributed to abdominal aortic aneurysms, atherosclerosis, bladder cancer, cataracts, cervical cancer, chronic obstructive pulmonary disease, coronary artery disease, diminished health status, esophageal cancer, hip fractures, kidney cancer, laryngeal cancer, leukemia, low bone density, lung cancer, oral cancer, osteoporosis, pancreatic cancer, peptic ulcer disease, pneumonia, stomach cancer and strokes.

4. Tobacco use is harmful to the brain

Several studies have shown evidence that chronic tobacco use promotes a decline of mental functioning, with or without a family history of dementia or Alzheimer's disease.

5. Smoking can cause blindness

Smokers are more likely to develop age-related macular degeneration. Macular degeneration can result in blindness because of the loss of 'straight-ahead' vision that we use for activities such as reading, hobby work and driving a vehicle.

FLU SHOT MYTH BUSTERS



Many people believe some existing myths about the flu shot.

Below are FACTS to help overcome those myths!

MYTH: If I get the flu shot, I'll get sick.

FACT: The flu shot is an inactivated virus, not a live virus, so it can't make you sick! You may experience mild side effects including soreness, redness or swelling at the site of vaccine; aches, fatigue, low grade fever and headache. These side effects are mild and are not the flu.

 $\boldsymbol{MYTH:}\;$ If I get the vaccine too early in the year, it won't protect me.

FACT: You should get the flu shot as soon as it's available, it takes 1-2 weeks to become active and it lasts about a year.

MYTH: If I'm allergic to eggs, I can't get the vaccine.

FACT: The flu vaccine is made using eggs. As a result, the vaccine has tiny amounts of egg protein in it. However, this doesn't necessarily mean that if you're allergic to eggs that you can't get a flu shot. In many cases, flu vaccines can be given safely to someone with an egg allergy.

If you've had a reaction to eggs in the past, talk to your doctor before getting a flu vaccination. Your doctor may send you to a physician who specializes in allergies. A skin test may be needed to see if you truly are allergic to eggs. A nurse or doctor will scratch a tiny amount of egg protein on your skin and watch to see if your skin reacts to it.
