 - Catalog Description: "Investigates..."
 - Catalog Description: "Focuses on demonstrating intellectual..."
 - Catalog Description: "Examines the effect technological advances have had on various disciplines..."
 - Catalog Description: "Discusses theories..."
 - Needs statement about 143 at end of catalog description. "Completion of COSC 143 fulfills the Liberal Studies Dimensions of Wellness requirement. Other 143 courses will also fulfill this requirement, and any of these courses may be substituted for each other and may be used interchangeably for D/F repeats but may not be counted for duplicate credit."
 - Learning Outcome 2: should it be as written on page of proposal.
 - Objectives in LS should be used for course outcomes.
 - The course will help students identify the positives and negative aspects of computer and cyber safety.
 - Number 5 on page 4 and the again on Page 10: "download apps" suggest "download approved apps that have been shown to be successful in monitoring physical wellness and use illustrative examples that demonstrate "False hope" apps.
 - Proposer can focus on health or wellness. A course does not need to do both.
 This course can focus on the wellness of computers and not get into the health
 aspects.
