

NOTICE TO IUP EMPLOYEES

IT IS IMPORTANT TO TELL YOUR EMPLOYER ABOUT YOUR INJURY.

Section 306(f) of the Pennsylvania Workers' Compensation Act provides for the payment of medical treatment for work-related injuries. The information below describes your responsibilities if you are injured. PLEASE READ CAREFULLY.

IN CASE OF WORK-RELATED INJURY OR ILLNESS

1. If you suffer a work-related injury, your employer or its insurance company must pay for reasonable surgical and medical services and supplies, orthopedic appliances and prostheses, including training in their use.
2. To ensure that your medical treatment will be paid by your employer or insurance company, you must select from one of the physicians or other health care providers listed below:

3. If you need treatment, you must continue to visit one of these providers listed above for 90 days from the first date of treatment.
4. After this 90-day period and if you still need medical treatment, you may choose to go to another physician or other health care provider for treatment. You should notify your employer and its insurance company of this action within five days of your visit to the provider or your choice.
5. Your medical bills will be paid for if your physician or other health care provider files reports as required. These reports must be filed within 10 days after your first visit and at least once a month for as long as treatment continues.
6. If one of the providers listed above refers you to another physician or health care provider, your employer or its insurer will pay the reasonable bills for these services.
7. If you are faced with a medical emergency, you may secure assistance from a hospital or physician or other health care provider or your choice. You must then seek subsequent treatment from a physician or other health care provider listed.
