Use this application to obtain an I-20 or DS-2019 form to bring your **spouse and/or dependent children** to the US. **Parents or other relatives are NOT eligible.** The OIE will issue an I-20 or DS-2019 for a fiancé(e), but keep in mind that in order to obtain a dependent F-2 or J-2 visa, your spouse will need to demonstrate proof of the marriage during the visa interview. Dependent children must be unmarried and under 21 years of age.

You must demonstrate the ability to support your dependents by providing **proof of additional funding (\$5,000 for a spouse and \$3,000 for each child)** in addition to the funds used to cover your tuition, fees, and living expenses. This amount must be shown regardless of the length of time your dependent(s) will stay in the US.

Please write your dependents' names exactly as they are written in their passports, clearly indicating any spaces or dashes. Your dependents should follow the same format when they complete their visa applications and I-94 cards. You may attach additional sheets if necessary, indicating any spaces or dashes. REQUIRED DOCUMENTATION

- A copy of your proof of funding, such as a recent official bank statement; a letter (on bank letterhead with the bank officer's signature, seal or stamp) confirming your funds; or another letter of funding from a sponsor. Multiple funding sources are permitted.
- A copy of your most recent I-94 card, if in the U.S.
- Copies of the passport identification page for each dependent, where available.
