

IUP ELECTRONIC FUND TRANSFER GIFT FORM

Thank you for your commitment to Indiana University of Pennsylvania. When you participate in the EFT program, your gift will be automatically transferred each month from your bank account directly to the Foundation for IUP.

A record of each gift will appear on your bank statement, and you will receive an annual receipt for tax purposes. All gifts provided to the Foundation for IUP originating as EFT transactions comply with U.S. law.

2. Return the completed enrollment form with a voided check, if available. Your EFT gifts will begin transferring within 45 days and will occur on the 15th of each month.
