catchphrase, "the Power of an IUP economics degree." What we mean by that is the ability of a degree in economics from IUP to significantly shift the outcomes for our graduates. By extension, we ourselves feel blessed at the number and reach of the students whom we have had the privilege of teaching. These are individuals about whom we can tell personal stories of achievement and success, whether they are working in Indiana or Johnstown, Pittsburgh or Harrisburg, Washington, DC, or New York City, Nepal or Africa, or anyplace else where they've chosen to at least temporarily call "home." These are individuals who rank among the numerous students who have earned a range of graduate degrees (Master's, Ph.D., J.D., etc.) in a wide variety of disciplines. In other words, you and your IUP stories motivate, excite, and inspire us to provide the best undergraduate education in economics possible!

Now, collectively, all of this IUP story telling brings us to why the current Department of Economics chairperson and newsletter editor, Dr. David Yerger, asked us to write this article for this fall's newsletter. As some of you may have read in the Summer 2017 issue of the *IUP Magazine*, we have made a multi-year financial commitment to the Foundation for IUP to establish the Drs. Jozefowicz Department of Economics Scholarship.

One reasonable and logical question to ask is, "Why now?" Well, it's certainly not because either of us has any plans to retire or otherwise leave IUP any time in the near future! However, as we find ourselves in the midst of our 19<sup>th</sup> year of teaching undergraduate economics at IUP, we realize that our tenure has spanned an entire generation of students. In fact, it is somewhat sobering to think that the students who sit in our classrooms today were not even born when we arrived at IUP as newly minted Ph.D.'s and assistant professors! Thus, we admittedly are hoping that the scholarship may serve to reconnect us afresh with the generation of IUP alumni who have earned their diplomas over the last two decades. By "putting our own money where our mouth is," we also are hoping that our commitment will encourage you, whether as a more recent or more mature Economics alum, to join with us in giving back to the institution that provided you with a start on your career path, whether through this scholarship fund or via the multitude of other giving opportunities available through the Foundation for IUP. Furthermore, another dimension of our desire to give derives from household-level parenting decisions. We want to tangibly demonstrate a commitment to charitable giving for our eleven-year-old daughter, Abigail, and instill in her the importance of "giving back" across a range of our personal passions, namely, IUP scholarships, church ministries, and adoption-related organizations.

You also may ask, "Why a scholarship?" Over the course of roughly the last five years during the spring semester, the IUP Office of Annual Giving, under the leadership of its director Emily Smeltz ('01, M'02), has conducted the University Family Campaign to encourage IUP staff, faculty, and administrators to support the institution. Each year during the University Family Campaign, the College of Humanities and Social Sciences (CHSS) Dean, Dr. Yaw Asamoah, offers an incentive to encourage participation whereby donations to funds within CHSS are partially matched. Thus, those of you who studied principles of economics from one of Greg Mankiw's textbooks may recall Principle #4, which states, "People respond to incentives." Despite arguments to the contrary, economists are people too, so in response to the opportunity to leverage the matching incentive, we have increased our household giving to IUP in recent years. We have directed most of that giving to support existing Department of Economics scholarships. Those funds all have reached the necessary endowment levels for disbursement, and we have witnessed firsthand the impact that those scholarships have had in the lives of their recipients.

Thus, it is fair to say that the past generosity of many alumni, friends, and supporters has provided inspiration for this scholarship. On the one hand, we could wait until closer to the end of our IUP careers when theoretically some potential donors might have the inclination and ability to make larger gifts. However, we feel strongly that the need for financial assistance for our students is undeniably present now, and we would prefer to have the chance to personally witness how this type of investment in the lives of our students may allow them to continue to excel. After all, as economists we understand that any gift, regardless of size, adds up, and it will be compounded over time.

### **GREETINGS FROM THE CHAIR:**

#### Greetings Alumni,

If by some chance you're starting here with the newsletter, I encourage you to stop and first read the lead article by the Drs. Jozefowicz on their decision to endow a department scholarship. They have consistently given their time to students inside and outside of the classroom ever since their arrival in 1999, and now they are extending their support of our students even further. The department is deeply appreciative of both their financial generosity and strong commitment to our students.

As an alum of the department, you had plenty of experience with the department's emphasis on undergraduate education. Since its inception, the economics department has granted only undergraduate degrees. I would like to use this newsletter, however, to highlight some of the department's involvement in graduate education. For many years the department has taught managerial economics for the MBA program in the Eberly College of Business. The MBA offerings have expanded over time to include on-campus, off-campus at various Western Pennsylvania sites, and international locations. In a future letter I will provide more complete details of the department's contributions to IUP's genuinely global and expanding MBA offerings, but my focus here will be on the department's second area of graduate education: the Ph.D. program in Administration and Leadership Studies, Nonprofit and Public Sectors (ALS).

The ALS doctorate is offered by the Department of Sociology. It is structured for working professionals, using a cohort model. In even-numbered years a new cohort of 15-20 students start at the Indiana campus and in odd-numbered years a similarly sized cohort begins at the Dixon University Center site in Harrisburg. The program is designed to give students both theoretical and applied knowledge on organizational structure and leadership, along with the qualitative and quantitative tools needed for effective research in their areas of interest. Students come into the program from a wide variety of backgrounds including human services, health services, government agencies, college faculty and administrators, K-12 administration, criminal justice, military, and the business sector.

The ALS program began in 1998, and was expanded to the Dixon campus in 2001, with an initial emphasis on the human services sector. Based on program review and clear interest of students outside of human services, the ALS program was revised in 2005 to its broader emphasis of today. This revision brought the economics department into the program. Dr. Radell developed and for ten years taught ECON 820: Managerial Economics for Decision Making & Leadership. ECON 820 is one of the eight required core courses (3 cr) for the program. Recently, Dr. Vick has assumed ECON 820 teaching responsibilities. I teach another required course, LDRS 811: Administration in the Public Sector. Both of these courses are taught in the summer as the ALS program is year round. Economics faculty also serve on, and chair, dissertation committees.

Teaching a group of primarily mid-career professionals who have formed themselves into a supportive cohort is a rewarding experience, as is helping them advance their professional goals. Some of you may find the ALS program of potential interest to you or someone you know. If so, I encourage you to visit the sociology department's web site for more information and to contact me directly. I would be happy to discuss the program with you, or anyone else, in more detail.

The Donald A. Walker Department of Economics Scholarship and the Robert J. Stonebraker Scholarship for Economics were established to provide a lasting tribute to acknowledge the impact of these (emeriti) professors on economics students during their tenure at IUP. Scholarships can also be established by alumni. Dr. Karl McDermott set up an endowed scholarship to recognize the impact of his IUP education on his professional career and to provide scholarship assistance to future economics students. These funds will continue to supply annual scholarships for IUP students for years to come. In addition, the Drs. Jozefowicz Department of Economics Scholarship has recently been established (see lead article on page 1). The Economics Department Scholarship provides scholarships to students focusing their studies in the degrees/programs offered through the Department of Economics. As of May 2017, **Drs. Christopher R. Jeffords** and Jonathan Warnock (IUP Department of Geoscience) assumed the leadership responsibilities of the Sustainability Studies program and minor. They took over for Drs. **Dr. Yaya Sissoko** (pictured on right) taught Principles of Macroeconomics, Principles of Microeconomics, and Monetary Economics at Juan University (JNU) in Guangzhou, China, over the summer. Every year, JNU invites faculty from the U.S. to teach at one of their 6 campuses in China and Taiwan. The program runs for 5 weeks over the months of June and July. This was Dr. Sissoko's second time visiting China.

**Dr. Alexi S. Thompson** presented "The Exchange Rate Regime and Balance of Payments in Greece: Floating Drachma versus Fixed Euro" (co-authored with Dr. Henry Thompson, Auburn University) at the 5th International Ph.D. Meeting in Economics 2017 at the University of Macedonia in Thesaloniki, Greece, in July 2017.

Results were presented to the Cumberland County Criminal Justice Policy Team and research staff from the Pennsylvania Commission on Crime and Delinquency in August 2017.

**Dr. Brandon C. Vick** recently published an article titled "Measuring Links Between Labor Monopsony and the Gender Pay Gap in Brazil" in the *IZA Journal of Development and Migration* **2017**, **Volume 7**, **Issue 1**, **pp. 1-28**. This paper focuses on gender differences in job mobility and earnings for workers in Brazil.

The Foundation for IUP received a \$25,000 multi-year commitment from **Dr. James J. Jozefowicz** and **Dr. Stephanie M. Jozefowicz** to establish the Drs. Jozefowicz Department of Economics Scholarship. *Thank you, Drs. Jozefowicz!* 

**Drs. Brandon C. Vick** and **David B. Yerger** (co-investigators), along with IUP Sociologists Dr. Susan Boser (primary investigator) and Dr. Alex Heckert, were awarded a \$50,000 grant from the Center for Rural Pennsylvania. Their research uses a unique, quantitative/qualitative methodology to advise on workforce policies to help persons with severe intellectual and development disabilities.

**Dr. David B. Yerger** has been elected as a Councillor to the Executive Council of the Association for Canadian Studies in the United States (ACSUS). ACSUS has a multi-disciplinary membership of academics, policy analysts, and government officials committed to raising awareness and understanding of Canada and the bilateral relationship.

Economics major **Courtlyn Adams** and Dr. Yuliya Melnikova of the IUP Department of Mathematics presented, "Investigation of Attendance and Homework Time in College Algebra," on Wednesday, November 15, 2017, as part of the Math Department Colloquium. The research analyzes the transition of students from Intermediate Algebra to College Algebra courses at IUP with a particular emphasis on the transition from a self-paced course in a lab environment to a traditional lecture-based course. Courtlyn worked with Dr. Melnikova on the statistical analysis during her participation in the IUP Research Experiences for Summer Scholars program during summer 2017.
