### **RECOLLECTIONS ON DR. ARTHUR H. MARTEL** BY CARL HISIRO ('76)

Editor's Note: In December I received an email from Economics alumnus Carl Hisiro ('76). Part of his email message read "I really was saddened to read about Dr. Martel's passing. Dr. Martel's influence on me while at IUP was immense. I have written a tribute to him that I would like you to consider publishing in the next newsletter. I wanted to convey in my message what Dr. Martel meant to me and to current students about what an education at IUP can mean for them." A most sincere thank you, Carl, for your thoughtful tribute to Dr. Martel. I am sure there are many news-letter readers who agree with you as well.

I recently read with great sadness of the passing away of Dr. Arthur H. Martel on November 15, 2019. When I look back at my time at IUP from 1972-1976, I can say without question that Dr. Martel had the most impact and influence on me as a student and on my ultimate career path.

I was an Economics major from day one when I started at IUP in September 1972, but I didn't know for sure what I wanted to do with my degree after I graduated. It was in my junior year when I took a course titled "Government and Business" that was taught by Dr. Martel that changed everything for me. While I didn't know for sure what would be covered in the course, I figured I would like the class because I had a heavy interest in government as I was already double majoring in political science, and what economics major doesn't have an interest in business, right?

As it turned out, the class was all about the federal antitrust laws, particularly learning about the Sherman and Clayton Acts that protect our free enterprise system from anticompetitive conspiracies and monopolization that can adversely affect price and/or output. I loved it. In fact, I loved the class so much I decided to take the LSAT that next summer and apply to law school to become an antitrust lawyer.

I also loved the way Dr. Martel taught the course, which was very similar to how a law school class would be taught on the subject. After that class, I tried to take as many classes as I could that were taught by Dr. Martel in the Economics Department. In fact, I had the pleasure of taking him four more times before I graduated, including classes in labor law, labor economics, and an independent study my last semester where I studied and wrote a paper on the trilogy of U.S. Supreme Court cases involving United States Steel in the first half of the 20<sup>th</sup> Century.

I did attend law school, going to Duquesne University School of Law in Pittsburgh immediately after graduation. I took antitrust law at Duquesne taught by a professor who had a distinguished career in antitrust enforcement at the U.S. Department of Justice. I received an "A" in that class, and relied heavily on my notes from Dr. Martel's Government and Business class to supplement my law school notes. I interned with the Reed Smith law firm, the largest firm in the state after my second year, and did some antitrust work for the firm. I also did all of my Duquesne Law Review writings on antitrust issues.

I graduated first in my law school class in 1979 and always attributed my success to the education I received at IUP, especially the classes I took with Dr. Martel. I stayed very close with Dr. Martel, and he attended my wedding in May 1979 in Indiana, PA, days after taking my last law school final.

By the next year, I accepted a position as deputy attorney general with the Pennsylvania Office of Attorney General's Antitrust Section, where I had the privilege of working on some of the biggest antitrust cases affecting Pennsylvania and its citizens over the next two decades. The last four years I was the section's chief during which we recovered over \$90 million for the state and its citizens and had a major impact on hospital mergers in the state. I finished my career with the Pennsylvania Public Utility Commission where I handled many competition and merger cases.

During my time at IUP, I was very active within the Economics Department, becoming president of the Economics Club my junior and senior years, and establishing a chapter of Omicron Delta Epsilon, the International Economics Honors Society, at IUP in 1975 and becoming its first president on campus. After graduating law school, Dr. Martel invited me on several occasions to speak at his Pre-Law conferences at IUP to help students interested in attending law school, and the Department itself invited me to speak at its graduation ceremonies. I have always enjoyed my time at IUP and can thank Dr. Martel especially for providing me with the guidance and direction I needed to have a successful legal career.



### **STUDENT SPOTLIGHT: DANIELLE HOBBINS** Recipient of the Karl A. McDermott Scholarship for Economics

Editor's Note: Dr. Karl McDermott ('76) received a BA in Economics from Indiana University of Pennsylvania, an MA in Economics from the University of Wyoming, and a PhD in Economics from the University of Illinois at Urbana-Champaign. Dr. McDermott is the Ameren Distinguished Professor of Business and Government at the University of Illinois at Springfield. In addition to this appointment, he is also a special consultant with NERA Economic Consulting. Dr. McDermott established the Karl A. McDermott Scholarship for Economics. Since 2011, this scholarship has been awarded annually to a student enrolled full-time at IUP. Criteria for the scholarship include: the student must have a declared major in Economics; preference for female students to overcome the underrepresentation of women in economics and related professions; and the student has demonstrated overall academic achievement and the promise for future success.

Danielle Hobbins, a junior from Gibsonia, PA, was the recipient of the Karl A. McDermott Scholarship for Economics for 2019. Danielle has a double major in Energy Management and Economics.

When asked why she chose IUP, Danielle says, "The first time I visited the IUP campus as a senior in high school, I could immediately picture myself spending the next 4 years of my education here. I saw many pros to the smaller class sizes at IUP, such as increased discussion within the classroom and the ability to foster relationships with professors and students within my department. Additionally, IUP offers a high-quality education at a reasonable price point."

Danielle says she added Economics as a second major while taking her first economics course, Principles of Macroeconomics, with Dr. Jozefowicz. "I enjoyed going to every class and looked forward to learning something new during each lesson. As I learned more about the department and the opportunities available with an Economics degree, I decided that adding an Economics major was the right decision for me."

Danielle says the Department of Economics and IUP have impacted her life in many ways. "Within the Department of Economics, I am constantly being offered opportunities from the faculty. For example, I have met Dr. Michael Mann, the distinguished professor of Atmospheric Science at Pennsylvania State University, through the department. I have also had the opportunity to meet with alumni who are employed at various places, such as The Office of the Comptroller of the Currency. Additionally, the faculty has supported my academic endeavors by writing recommendations that assisted in my receiving the Discover Norway Educational Grant. On the IUP campus, there is always an opportunity to take part in such things as community service, professional networking events, and workshops. Attending available events on campus helped shape me into a more well-rounded individual."

Danielle is an IUP Provost Scholar and the recipient of a Discover Norway 2020 educational grant. Currently, she is the President of the Management Association, Vice President of the College of Business Student Advisory Council (COBSAC), and a member of Phi Gamma Nu, which is an organization that promotes the study of business.

Danielle notes that "Attending college is a huge privilege, and I am grateful that the hard work I have put towards making my time at IUP meaningful has been acknowledged. Receiving the Karl A. McDermott Scholarship has encouraged me to maintain my work ethic, as well as lessened the financial burden and the stress associated with the costs of college." As for plans for the future, Danielle is thinking about attending graduate school.

### **FACULTY NOTES**

A recent paper by **Dr. Christopher R. Jeffords** and Joshua Gellers (University of North Florida) explores the emergence of environmental rights in the Asia Pacific region. Published in *Asia Pacific Journal of Environmental Law*, "Environmental Rights in the Asia Pacific Region: Taking Stock and Assessing Impacts" extends the contributions Drs. Jeffords and Gellers made to the United Nations report titled "Accelerating Progress: An Empowered, Inclusive and Equal Asia and the Pacific."

In his role as the executive secretary of the Association for Social Economics (a member organization of the ASSA), **Dr. Christopher R. Jeffords** helped organize and coordinate various activities at January's ASSA 2020 annual meeting in San Diego, CA. In addition, Dr. Jeffords served as the panel chair for the "Topics in Social Economics" session and he presented "The Growing Trends of Human Rights Research in EconLit-Indexed Journals from 1972–2018." The Association for Social Economics sponsored 11 different sessions where approximately 45 different papers were presented.

**Dr. Yaya Sissoko** presented a paper titled, "Inside the Classroom: Learning from the 2008 Financial Crisis and the Subprime Meldown" (co-authored with Dr. Brian Sloboda), at the Allied Social Sciences Association (ASSA) Conference for the Poster Session of the Committee on Economic Education (CEE) in San Diego, CA, on January 3-5, 2020. In addition, Dr. Sissoko attended two other events at the ASSA Annual Meeting. As a board member, Dr. Sissoko attended the Annual Board Meeting of the African Finance and Economic Association (AFEA) held on Saturday, January 4. As a member of the American Economic Association (AEA), Dr. Sissoko attended the AEA Continuing Education Workshop on Climate Change Economics on January 5-7.

**Drs. Alexi S. Thompson's** and **Yaya Sissoko's** paper titled, "The Price of Cocaine and the Colombian Peso: An Empirical Investigation," was published in the *Global Economy Journal*, Vol. 19, No. 03, 2019.

**Dr. Yaya Sissoko** was invited as a panelist at the "Bamako Forum: Africa on the Horizon 2040: Between Memories and Future" in Bamako, Mali, on February 20-22, 2020. A unique event of its kind in Africa, the Bamako Forum is a high-level space for reflection on the future of the continent. Focused on the challenges of African development, it is a place and a time of exchanging ideas and dialogue where business leaders, politicians, public decision-makers, academics,

researchers, and experts meet students, representatives of civil society, and the media from the African continent and from other continents. The forum aims to promote the mixing of knowledge and the sharing of knowledge and best practices in a participatory approach in search of solutions to demographic, technological, and climate challenges and to the consolidation of peace, security, and inclusive development and sustainability in Africa. The 2020 edition provides about 2,000 direct participants.

*Congratulations* to **Dr. Willard W. Radell** who was awarded the distinguished Professor Emeritus recognition for his outstanding contributions to the Department of Economics. Dr. Radell retired in August 2019 after 38 years of service to IUP.

In March, **Dr. Willard W. Radell** was the featured reviewer of The New Century Club/Friends of the Library's Book Breakfast held at St. Andrew's Village in Indiana, PA. Dr. Radell discussed the book "The Economists' Hour: False Prophets, Free Markets and the Fracture of Society" written by Binyamin Appelbaum, a *New York Times* editorial writer.

The paper "Quebec's Fracking Restrictions: Squandered Opportunity or Prudent Conservation?," by **Drs. David B. Yerger** and **Todd B. Potts** has been accepted for publication and is forthcoming in the *American Review of Canadian Studies*.

Drs. Amber Stephenson (Clarkson University), Alex Heckert (IUP Sociology), and **David B. Yerger's** paper "Examining College Student Retention: A Closer Look at Low Self-Control" has been accepted for publication and is forthcoming in the *International Journal of Educational Management*.

**Dr. Brandon C. Vick** published "Measuring Multi-Dimensional Deprivation Among U.S. Veterans" in the journal *Social Indicators Research* (https://doi.org/ 10.1007/s11205-020-02299-7). In the paper, Dr. Vick used the *2012-2017 Current Population Survey Veterans Supplement* to estimate a deprivation index. He differentiated veterans by branch and combat service and measured outcomes related to disability, family income, educational attainment, and long-term unemployment. In a given year, an estimated 7% of veterans (about 60,000-70,000 veterans in terms of the population) experience two or more deprivations simultaneously. Younger veterans, Army, and those living in rural areas have higher odds of being multidimensionally deprived.

**Drs. Stephanie M.** and **James J. Jozefowicz** participated in the virtual meeting of the Pennsylvania Economic Association (PEA) Officers on Friday, March 27, 2020. Dr. Stephanie Jozefowicz serves as PEA secretary and Dr. James Jozefowicz is an ex-officio member of the PEA Board of Directors.

**Drs. Stephanie M.** and **James J. Jozefowicz** participated in the virtual meeting of the IUP Leadership Society Advancement Council on Tuesday, April 21, 2020.

Congratulations to **Dr. Brandon C. Vick** who was selected as the 2019-20 recipient of the *Garvin-Kort Faculty Award for Research in Economics*. Generous donations from alumnus **Dr. John Kort ('74)** and the late **Dr. Alexander Garvin**, economics faculty 1969-1998, provide support and recognition for faculty research. Dr. Vick's paper "Measuring Multi-Dimensional Deprivation Among U.S. Veterans" has been accepted for publication in *Social Indicators Research*, a highly ranked journal in the social sciences. Once we all are again on campus, Dr. Vick will give a seminar to students and faculty highlighting this research.

### **STUDENT NOTES**

Students from **Dr. Brandon C. Vick's** Health Economics course partnered with students enrolled in Dr. Abigail Adams' Medical Anthropology and Dr. Amanda Poole's Applied Anthropology courses as part of research for the 19th annual Appalachian Teaching Project Symposium in Washington, DC, in December 2019. Titled the "Opioid and Work Project," the students collaborated with the Armstrong-Indiana Drug and Alcohol Commission to identify the occupations and industries that have the highest prevalence of opioid use by workers in that sector and created data-informed recommendations for various labor stakeholders. The project was a multi-method approach that engaged both qualitative and quantitative data to better understand the landscape of the opioid epidemic in Indiana County and its impact on the local workforce. "I am very proud of the students representing IUP as they continue their important course-work toward building a better future for their communities," said Appalachian Regional Commission Federal Co-Chairman Tim Thomas. "These students are engaged in work that benefits an entire region, and represent an institution that has worked consistently within our region to prepare our next generation of leaders."

Twelve economics majors have been named to the Fall 2019 list of IUP Provost Scholars in recognition of their completion of at least 45 credits at IUP while earning a cumulative grade-point-average of 3.5 or higher.
