Terms & Conditions

One-Way Rentals: All authorized one-way rentals will be charged the Daily Rate with a per mile charge that will be applied to all miles driven during the term of the rental from the date the rental originates.

One Day Surcharge: A \$7.00 surcharge will be added to one-day rentals commencing on M, T, W or Th.

Protection Products: Damage Waiver includes Full DW (\$0 Deductible); Liability includes Split Limits (100/300/50).

Rental Mileage Allowance: Includes 3,500 miles per rental excluding pickup trucks, cargo vans and 12/15 passenger vans which include 150 miles/day, 750 miles/week, and 3,000 miles/month. Additional miles are charged \$0.25/mile.

Young Renter: Fee will be waived for Eligible Renters who are twenty-one (21) to twenty-four (24) years old renting for Business use.

Terms & Conditions

Daily Rates: Based on a 24-hour billing cycle.

Mileage Charges: Base Rental Charges for rentals in the U.S. include free miles as set forth above. Any additional miles will be charged at the rate set forth above.

Inspection: Customer agrees to require its Eligible Renters to perform daily visual inspections on rental vehicles including but not limited to the inspection of headlights, running lights, brake lights, and turn signals, the identification and notation of damages and the checking and maintenance of all fluid levels and manufacturer recommended tire pressure. Maintenance: Upon three (3) days' prior notification from EAN or an Affiliate, Customer agrees to make themselves and each vehicle available for the purposes of inspection and/or maintenance every thirty (30) days. See Agreement for full details.

Age Requirements: Customer shall be age 21 or older (or 18 or older if required by law) for the rental of these vehicle classes. Customer shall be age 21 or older to be eligible for Driver Protection Products.

Exclusions: Rates do not include applicable taxes, surcharges, refueling, one-way, drop-off, delivery, pickup, mileage, youthful driver or additional driver charges; or, except as set forth below, any optional products or services such as damage waiver ("DW"), or liability protection ("LP").

Protection Products: Damage Waiver and Supplemental Liability Protection included only in cargo van and pick-up truck rate for truck branches. For all other truck classes, Damage Waiver and Liability are available at an additional cost.
