#### **CRIM Visiting Research Scholar Brown Bag Series**



Dr. Wonyoung Song was the first presenter in a series of virtual brown bag discussions hosted by the College of Health and Human Services Research Committee in conjunction with the Department of Criminology and Criminal Justice. Dr. Song's presentation entitled *Two Heads are Better Than One: Introducing One Head from South Korea* provided the audience with an introduction to Dr. Song, an overview of his research interests, and discussion of his most recent research projects and future collaborative research projects with new partners.

Dr. Wonyoung Song is serving IUP this year as a Visiting Research Scholar sponsored by the College of Health and Human Services, Department of Criminology and Criminal Justice, and the IUP Center for Research in Criminology. Dr. Song is a Professor in the Department of Counseling and Psychotherapy at Konyang University. After earning a BA from Chungnam National University (South Korea), Dr. Song earned MA and PhD degrees in Clinical Psychology from Yonsei University. Dr. Song's expertise includes various research methodologies, the understanding of anxiety and other psychological conditions, and assessing the behaviors of sexual offenders. While at IUP, Dr. Song is working with Dr. Bitna Kim (CRIM) on a study investigating the validation of instruments that predict recidivism among sexual offenders.

Dr. Song is working out of Wilson Hall and is available for collaboration through December 2022.

### It's a SNAP - Celebrating National Nutrition Month

The Student Association of Nutrition and Dietetics (SNAP) celebrated National Nutrition Month in March with a smoothie sale, macaroni and cheese crockpot cook-off competition, and a program with a nationally known speaker.

The smoothies featured banana, coconut, and spinach flavors, with students, faculty, staff, and community members stopping by the Hadley Union Building for a taste.

She is also co-founder of INSPIRD to SEEK, mentoring nutrition entrepreneurs and practitioners who are challenging the status quo of our health industry, integrating a non-diet approach and HAES philosophy into all health care settings.

# **Congrats to RT Leadership Award Recipient**



The recipient of the Stacy Lynn Sabocheck Leadership Award demonstrates initiative, leadership, commitment to the profession, and excellent academic and clinical performance, as well as qualities that make him/her most likely to make a positive impact on the profession of respiratory and health care. This year's recipient was senior Alyssa Close.

In 2002, senior Stacy Lynn Sabocheck won the then-named Leadership Award, but sadly passed away shortly after graduation, and in her honor the award was renamed the Stacy Lynn Sabocheck leadership Award. # Kim Publishes on Publication Bias in the Discipline

Dr. Bitna Kim's study entitled "Publication bias: A 'bird's-eye view' of meta-analytic practice in criminology and criminal justice" was recently published in the *Journal of Criminal Justice*. The study examined recent meta-analyses in the fields of criminology and criminal justice (CCJ) to capture a snapshot of the current state of publication bias practices and provided practical guidelines and recommendations on how to address the issue of publication bias in meta-analytic reviews. The content analysis reviewed 64 meta-analyses published in top-tier journals in the CCJ field between 2019-2020 and concluded there is a need to continue monitoring the quality of meta-analyses to gain a comprehensive picture of how bias leaves a potential imprint in CCJ research.



## **ERHSA Remembers Program Co-Creater Marty Morand**

The Employment Relations and Health Services Administration department (formerly the Industrial and Labor Relations Department) lost its "co-creator" of the program and department, Martin (Marty) Morand. Marty, who died March 5, 2022, at the age of 94, was a tireless organizer, skilled negotiator, and preeminent practitioner of worker education. A graduate of Cornell, he was deeply rooted in New York Jewish union culture, especially the International Ladies Garment Workers Union (ILGWU). He got to know Pennsylvania through years of servicing and negotiating for the union garment shops that fled New York City and settled in Pennsylvania after World War II. Marty threw himself into the transition of the Association of Pennsylvania State College and University Faculties (APSCUF) from a high-minded association into a serious union that negotiated a contract considered the best of its genre for decades. He also used his organizer position to create a degree-granting Industrial and Labor Relations Department and a worker-oriented Pennsylvania Center for the Study of Labor Relations both at IUP. His partner in the creation of these entities, Donald McPherson called Marty "the most successful strategist I have ever known. His thinking through of an issue, of moves to make, of interests of the parties, of forces to set in motion, was eons ahead of those with whom he was interacting to accomplish some goal."

### Criminology MA "2022 Best Online Program"

IUP's Department of Criminology and Criminal Justices' online MA program is ranked in the top 32 programs in the nation according to competitive rankings established by *U.S. News & World Report*. The publication's "Best Online Programs" are the only US rankings that evaluate specific online programs rather than lumping all of a college's online offerings into a single ranking, magazine editors said.

More than 1,200 programs were considered for inclusion in the rankings, which used five factors to evaluate programs:

- Faculty credentials and training (instructors with strong academic credentials);
- Services and technology (programs that incorporate diverse online learning technologies to allow for optimal flexibility for students);
- Engagement (courses that promote active participation between students and faculty responsiveness to student needs);
- Student excellence (accepting students with proven aptitudes, ambitions, and accomplishments); and
- Expert opinion (a survey of high-ranking academic officials in the discipline evaluating a program's reputation).

#### Video Tutorials Published by Sociology Faculty

Sage Publications recently invited Dr. Susan Boser to publish a series of Video Tutorials based on her scholarship on ethics in the context of community-based, or participatory, research. Filming was completed last fall. The Video Tutorials will be released in 2022 as part of the *Sage Research Methods Collection: Research Ethics*. The three 30-minute videos are "Introduction: How participatory research differs from traditional research design and the implications for ethics," "Using perspectives on power to design methods for participatory research," and "Complexity in insider/outsider relations: Implications for participatory research."
