These are not courses (Calculus II and III) that can typically be taken as the first and potentially only course in the Mathematics learning skills area (3-4 cr).

2. The Department, in the course proposal for MATH 219, states that it is currently a LS course. However, it is not listed as such in the catalog so we are returning the proposal for clarification.
