II. Course Revisions

History

16-63 HIST 196-7-8 Explorations in History – Course revision

Motion to return

Rationale: the justification/rationale does not clearly provide information about what the department is seeking. There appears to be two requests: one for the D/F repeat and another to allow these courses to be removed from the interchangeability aspect (overlap) they were approved for. In other words a student could get credit for each one of these courses that they would take. The committee did not feel that the courses are sufficiently different to warrant receiving credit for each one taken as they cover the appropriate liberal studies criteria with geographical variances. We felt that these courses were created and are similar in properties to the Dimensions of Wellness courses (143's). The committee felt that the rationale of students changing majors and then being required to take another HIST course was weak as these courses are typically counted by the department of the major the student is changing into to. The transfer credit rationale is also weak as over the past few years the LS office has worked with the admissions office to count most any HIST course that transfers in as meeting IUP's LS History requirement. The same is true for most AP credit transfers.

III. Program Revisions

Early Childhood Education

16-63 BSED Early Childhood Education – program revision

Ortiz/Asamoah - motion to provisionally approve based on recommendation from TECC – Passed: Unanimous.

Rationale: TECC representative Edel Reilly discussed the proposal with the committee and we agreed that TECC should be looking at this proposal as well.
