Pre-Accreditation Submission 9.8-1: Mental Health Services

## **Purpose**

The purpose of this policy is to ensure that all medical students have access to confidential, timely, and professional mental health services to support their emotional well-being, academic success, and personal development throughout their medical education.

#### **Policy Statement**

The medical school is committed to promoting the mental health and well-being of its students. Professional mental health services—including counseling, crisis intervention, psychiatric care, and referrals—shall be readily accessible, confidential, and free from academic or disciplinary reprisal.

#### Scope

This policy applies to all enrolled medical students, regardless of academic year or enrollment status (full-time or leave of absence), and includes services provided both on-campus and through affiliated providers. This includes confidential access to an effective system of counseling and mental health care from mental health providers, with a mental health provider available/accessible 24 hours a day, 7 days a week, and 365 days a year, accessible at all locations (including clinical rotation sites) where students receive education from the COM. Please refer to *Pre-Accreditation Element 9.8-3* for a listing of mental health services available to students at all teaching locations (including rotation sites) with service locations and hours.

#### **Guiding Principles**

- Mental health is an essential component of overall student wellness and professional development.
- Seeking support is encouraged and does not negatively impact a student's academic standing or future career.
- Services will be delivered in a culturally sensitive, trauma-informed, and inclusive manner.
- Providers of mental health care will not participate in student academic assessment or promotion decisions.

#### **Available Mental Health Services**

The school will provide or facilitate access to:

- Individual counseling and psychotherapy
- Crisis intervention and emergency mental health support
- Medication management and psychiatric services
- Workshops and support groups on topics such as stress management, burnout, anxiety, and resilience
- Referrals to community mental health professionals for ongoing or specialized care

# Services may be offered:

- On-site through the institution's health or wellness center
- Via telehealth platforms approved by the school
- Through external providers under agreement with the school

## **Access and Confidentiality**

- Mental health services are available by self-referral or referral by faculty, staff, or peers.
- Services are offered at no cost or reduced cost to students, and efforts will be made to minimize financial barriers to care.
- All mental health records are **confidential** and maintained separately from academic records, in compliance with FERPA, HIPAA (if applicable), and state law.
- Mental health providers will not be involved in the teaching, evaluation, or promotion of students under their care.

# **Crisis and Emergency Protocol**

Students in crisis will have access to **24/7 emergency mental health support**, which may include:

- A dedicated crisis hotline
- On-call licensed mental health professionals
- Coordination with campus safety or community crisis response teams when necessary

#### **Promotion of Services**

- Information about available mental health services will be clearly communicated during orientation, included in student handbooks, and regularly promoted via emails, class announcements, and the school website.
- Faculty and staff will receive guidance on how to recognize signs of student distress and refer students appropriately.
- All students will be required to meet with an administrator for a mental health/wellness check-in within the first semester of matriculation. Students who return to school after a Leave of Absence will be required to complete an administrator mental health/wellness check within 90 days of returning to school.
- Students will be able to request excused absences from lectures and clinical rotations

times to be able to attend mental health appointments.

# **Training and Education**

The medical school will provide periodic programming to:

- Destignatize mental health care
- Educate students on recognizing and addressing signs of burnout, depression, and anxiety
- Promote self-care, peer support, and available wellness resources

## **Student Leave for Mental Health**

Students may request a leave of absence for mental health reasons. These requests will be considered under the school's Leave of Absence Policy and handled with sensitivity and support for the student's well-being and academic reintegration.

# **Policy Review**

This policy shall be reviewed every two years, or more frequently as needed, to ensure it remains aligned with accreditation standards, student needs, and best practices in medical education.
