#### • Updates

- Mr. Donald Gamble, Director of the Center for Career & Technical Personnel Preparation, will retire on June 1. His replacement is Mr. Barnett Knorr.
- Dr. Creely reviewed the group's activities for the 2011-2012 academic year:
  - Five-year reviews were completed for 14 centers. During academic year 2012-13, centers in the College of Health & Human Services, Eberly College of Business and the School of Graduate Studies & Research will be reviewed.
  - Six centers were awarded assistance with updating their websites. Mr. John Hepler, from the School of Graduate Studies & Research, will continue to work through June with these centers.
  - Nine centers were awarded spring grants for travel and special projects, for a total of \$8,000. Ms. Stein said that her program's accreditation team remarked on the helpfulness of these grants each spring to keep their clinical materials updated.
  - The request for FY 11-12 annual reports will be sent to all center directors soon. Dr.
    Creely wants to move the due date up to mid-August this year, and will send an email to directors with that request.
    - Directors should not feel constrained by the template provided. The center's annual report should showcase your center's strengths.
    - Reports submitted after the due date will not be accepted this year.

#### • New Business - Presentation by Mr. William Speidel, Vice President for University Advancement

- Dr. Creely introduced Mr. Speidel, CFRE (Certified Fund Raising Executive), who has been at IUP since February 2011. Before coming to IUP, Mr. Speidel worked at the YMCA in Clarion, Butler County Community College, and Passavant Hospital.
  - Mr. Speidel presented the attached slideshow.
    - Dr. Krishnan mentioned that there are many international alumni who are not being asked to contribute.
    - Mr. Speidel asked that centers contact his office before approaching a corporation in order to coordinate IUP's efforts.
    - Dr. Krishnan asked if there is a conflict of interest in providing services and soliciting donations; Mr. Speidel clarified that *quid pro quo* solicitations would be unethical but approaching former clients for donations to help student and future clients would not likely present a conflict.
    - Dr. Creely said she would ask the C&I Directors to help her prepare a summary of the centers and institutes' work for Mr. Speidel.
      - Mr. Speidel said that stories about people who were helped by the center would work well in soliciting donations.
    - Mr. Moreau asked if each center should have its own Foundation account.
      - Mr. Speidel said the accounts should be active. If a center has a need and a use for donations, they should consider setting up a Foundation account.
