<p><u>Informational Webinar</u> February 22, 2023 3:00 PM ET</p> <p><u>Proposal Due</u> April 11, 2023</p>	<p><b>CDC – Center for Disease Control – REACH – Racial and Ethnic Approaches to Community Health</b></p> <p><i>This multi-component 5-year program aims to improve health, prevent chronic disease, and reduce health disparities among racial and ethnic populations with the highest risk, or burden, of chronic disease, specifically African American, Black, Hispanic and Latino, Asian American, Native Hawaiian/Other Pacific Islander, American Indian, and Alaska Native populations.</i></p> <p><b>Component A</b> is required and focuses on nutrition; physical activity; continuity of care in breastfeeding support; supporting national standards related to nutrition, physical activity, and breastfeeding in early care and education (ECE) programs; supporting implementation of family healthy weight programs; and tobacco prevention and control policies.
