 These resources are based on a behind the wheel program that is used by trained driver education teachers.

Purpose:

- to give adults supervising practice driving with a teen driver, an orderly, standard routine.
- To provide objectives and methods similar to those used by in-car driving instructors that may:
 - reduce stressful situations for adult and teen.
 - reduce risk by allowing the teen driver to gradually progress through skill levels and driving environments.
 - The "Be Ready, Be Safe, Be Responsible" approach, is the motto used by the Novice Driver Statewide Program, and is used in the PA Perceptual Driving Curriculum.

Permit valid for one year (can be extended)



6 months of logged practice time before testing

- Mandatory minimum 65 hrs.
- w/10 hrs. night &
- 5 hrs. bad weather

Proper supervision with:

- licensed driver at least 21 years of age
- licensed parent, guardian, person in loco parentis or spouse at least 18 years old

STAGE 2

JUNIOR LICENSE – AFTER PASSING THE DRIVING TEST, ALLOWS UNSUPERVISED DRIVING WITH RESTRICTIONS:







• NO NIGHTTIME DRIVING BETWEEN <u>11 P.M. AND 5</u> <u>A.M. *</u> NUMBER OF PASSENGERS MUST NOT EXCEED THE NUMBER OF SEATBELTS IN THE VEHICLE.



• PASSENGER RESTRICTIONS: NO MORE THAN ONE (1) PASSENGER UNDER THE AGE OF 18 WHO IS NOT AN IMMEDIATE FAMILY MEMBER UNLESS ACCOMPANIED BY DRIVER'S PARENT/GUARDIAN.



 AFTER 6 MONTHS ON A JUNIOR LICENSE, THE LIMIT IS INCREASED TO: NO MORE THAN 3 PASSENGERS UNDER THE AGE OF 18 WHO ARE NOT IMMEDIATE FAMILY MEMBERS UNLESS ACCOMPANIED BY ONE OF YOUR PARENTS

Unrestricted License

- •Issued at age 18 —
- Unlimited driving privileges to teens who have progressed through the graduated system and have a history of safe driving.

Unrestricted license before age 18:

- crash- and conviction-free for 12 months
- <u>completed an approved driver's</u> <u>education course</u>
- submit special form <u>DL-59</u> to PennDOT with a certificate of completion from an approved driver's education course.
 - An affidavit of consent from a parent, guardian, person in loco parentis or spouse who is at least 18 years of age must also be provided.

Eye screening and knowledge test

- If you fail the knowledge test:
 - The examiner will return the DL180 and DL180TD
- Keep your forms in a safe place since you must bring them with you when you are tested again.
- You may take the knowledge test <u>only one</u> <u>time per day</u> regardless of test location.
- If you pass:
 - A permit will be issued to you

PRACTICE, PRACTICE, PRACTICE

 Complete and log the mandatory minimum hours of practice driving time. (At <u>least</u> 60 hours,10 hours nighttime, 5 hours bad weather.) These are the minimum time recommendations.

Once the requirements are met, and the parent of guardian allows, the student may take the license test.

THIRD PARTY TESTING

TAKING THE ROAD TEST

Vehicle Controls:

- Operate horn, all lights, windshield wipers, parking brake, 4-way flashers, defroster, etc.
- Failure to operate any of the vehicle controls will result in a failure of the Road Test.

Parallel Park:

- Park your vehicle midway between two uprights in a space that is 24 feet long and eight (8) feet wide.
- Your entire vehicle must be completely inside the space
- You have one attempt to park using no more than three adjustments.

TAKING THE ROAD TEST

The examiner is the <u>only</u> passenger during the test.

- Gives directions where to drive and what maneuvers to make.
- Make notes on vehicle control, using turn signals or any other vehicle controls that may be necessary during the test.

•Unable to operate any vehicle controls

Violating <u>any</u> traffic laws

(failing to obey a stop sign, speeding)

- Driving dangerously or recklessly
- Making errors in safe driving practices
- Failing to follow instructions.
- Causing a crash
- Not using turn signals
