

Minutes of University Senate Meeting  
February 12, 1974

The University Senate meeting of February 12, 1974, was called to order at 3:30 P.M. in Pratt Auditorium by Chairman Goodrich.

Chairman Goodrich announced that the minutes of the December 4, 1973, Senate meeting had been accepted by the Board of Trustees. The minutes of the December 11 meeting had not been submitted in time for the December 7 meeting of the Board of Trustees.

Also absent but accounted for were Senators Hassler, McGovern, McCracken, Chaszor, Eisen, Godlasky, Grayburn, Isar, Corso, Fails, Givler, and Shpargel.

Chairman Goodrich reported on the following changes in the membership of the Senate: Dr. C. Donald Seagren replaces Senator Samuel Furguiele as a member-at-large from the administrative segment; three new undergraduate senators are Joye Mallison, Jon Simmons, and Dave Phelps who are replacing Senators Hammond and Kunkle; Crawford Jones representing the E.O.P. department has been elected to the Senate; and Cathy Wilson was designated as the Graduate Student Senator.

Chairman Goodrich appointed the following members to the Ad Hoc Committee on APSCUF-Senate Relationships. This committee was established at the December meeting to explore the relationships that could be established between the faculty organization, APSCUF, and the Senate. The senators are: Seelhorst, Burke, Walthour, Dietrich, Einsporn, and Wiley.

On a motion by Senator Chamberlain and a second by Senator Beck the minutes of the previous meetings were accepted as published. Motion carried.

Under Old Business, Chairman Goodrich ruled that the motion to re-consider the vote on the Minority Report of Committee B<sub>1</sub> be placed under Part IV of New Business.

The motion was seconded by Senator Glott and was carried.

On a question from Senator Tompkins concerning the criteria for graduate faculty and its relationship to the Graduate Council as a part of the Senate, Chairman Gallanar replied that this will be on the Agenda of the next Senate meeting.

Chairman of Committee G, Senator Lenglet, moved for the adoption of the following Committee G action:

That Whitmyre Hall be closed as a dining hall  
and re-assigned for other uses.

The motion was seconded by Senator Reefer and was passed.

A motion was made by Senator Jones that the report of the Ad Hoc Committee on the Student Cooperative Association Activity Fee be accepted. The motion was seconded by Senator Cessna and was passed.

Under New Business, Senator Bright gave a brief report as the representative of the Admissions Committee. He stated that prospects are dim, applications for September, 1974, are down 12%, and that I.U.P. is not getting as many applications as in the past. He emphasized that this is not an up-to-date report since the committee will be meeting February 13.

Senator Dietrich appealed to the assembly on the point of reconsidering the motion of the Minority Report of Committee B<sub>1</sub>. The motion to bring up the motion to reconsider the vote on the Minority Report of Committee B<sub>1</sub> passed at the November meeting of the Senate was made by Senator Dietrich and seconded by Senator Tompkins.

Senator Dietrich made a motion to appeal the ruling of the Chairman that the motion must be considered New Business. The motion was seconded by Senator Truxall. The vote was 48 in favor and 32 against.

Senator Landon moved that the Minority Report be brought up on the floor under New Business. Motion was seconded by Senator Gates.

Senator Davis spoke in favor of having the matter returned to the proper channel of Committee B<sub>1</sub>. He felt the report had to be considered as a whole and not item f considered in isolation. He further stated that he felt there was no hurry because the grades would not be changed until the end of the semester and perhaps by that time Committee B<sub>1</sub> would have a recommendation concerning it.

Senator Strawcutter pointed out that he felt that the students had had a choice in the deciding of this report. A great deal of time had been spent both by the Committee and by the Senate discussing the matter. He requested that this not be included under New Business.

Senator Armstrong pointed out that since item f had been considered

separately in the original action, he felt it could be considered separately at this time.

Senator Ferrara felt that this action wouldn't be overriding the action of Committee B<sub>1</sub> and questioned why considering it would be violating the Constitution.

Senator Dietrich gave three reasons why this matter should be re-considered: He has information which was not available before, questions during December 4 debate were not properly answered and can be answered now, and members of the Senate did not understand what they were voting on and registered a protest vote.

Senator Hazley questioned why Dietrich was not willing to let this matter go back to the Committee since he does have new information available.

Senator Davis spoke in favor of having the matter go back to Committee B<sub>1</sub>.

Senator Reefer spoke in favor of having the matter go back to Committee B<sub>1</sub> in view of all of the work Senator Dietrich has done on the Minority Report.

Senator Dietrich says that his political instincts indicated that if this matter isn't considered now it won't be considered at all.

Senator Petrosky called for question on closing debate. Seconded by Senator Gates. Motion passed to close debate.

The motion that new business "be put" on the floor (i.e., the Minority Report) was voted 31 in favor and 44 opposed. The motion was defeated.

Senator Lehman made the motion that the Senate direct Committee B<sub>1</sub> to give re-consideration the matter stemming from the fact that Senator Dietrich had additional information. The motion was seconded by Senator Reefer.

Senator Strawcutter pointed out that this matter would have to be added on the agenda after all the matters already dispersed to the sub-committees have been taken care of. He questioned whether Senator Lehman's motion implied any other procedure than what the Committee B<sub>1</sub> usually does. Senator Lehman said there weren't any special priority involved in the motion.

Senator Dietrich amended the original motion giving priority to this matter by Committee B<sub>1</sub>.

Senator Davis spoke against the motion as amended since the reason for the backlog of Committee B<sub>1</sub> items stems largely from so much attention given to this matter.

Senator Strawcutter pointed out to the members that if this is given priority, ". . .you ought to know before you do what items you are going to consign to next October."


Senator Woodard brought out that this Minority Report has gone through all the proper steps and he doesn't understand why it is reopened.

Senator Gallati felt the decision should be based on the new information that is now available.

Senator Gates called for a question on the motion. Debate ended.

The motion to direct Committee B<sub>1</sub> to pick up this problem with priority was voted upon. The motion received 36 votes in favor and 36 votes against. Motion failed.

The meeting was adjourned at 5:00 P.M.
