MINUTES OF THE UNIVERSITY SENATE MEETING

MAY 2, 1974

The May 2, 1974 meeting of the University Senate was called to order at 3:25 p.m. in Pratt Auditorium by Chairman Thomas Goodrich. Chairman Goodrich announced that this would be a dual meeting, combining the regular business of the Senate with the election of one Senate officer and members of Senate committees. He urged the Senate members, particularly those who would begin serving on the Senate in September, to bear with him during this time so that election's could be completed at this meeting, rather than calling another meeting to complete them. He also indicated that the new Senate members who were present were to be involved only in the elections and not in any of the matters to be voted upon by the Senate at this meeting.

Absentees included Senators Hadley, Chellman, McGovern, Murdoch, Bormann, Eddy, Gault, Sloniger, Sommer, Walz, Ferguson, Godlasky, Heiges, Smith, Waechter, Solley, Wilson, Armstrong, Barnes, Bobich, Brule, Corso, Cutitta, Einsporn, Fails, Givler, Hart, Kennedy, Murray, O'Hara, Quigley, Reefer, Ross, VanHorn, Walker, Willem, and Simmons.

Also absent but accounted for were Senators Bell, Davis, Hassler, Lafranchi, Sahli and Stapleton.

Upon a motion by Senator Hazley, seconded by Senator Bright, the minutes of the March 26, 1974 meeting were approved as published.

Under Old Business, Chairman Goodrich read a letter from Caryl Kline, a member of the Board of State College and University Directors, in response to the Senate's objection to the directive on accepting "D" grades on transfers from community colleges. Mrs. Kline indicated that she understood the position taken by I.U.P. and Millersville State College and that she planned to request data from other institutions similar to that submitted by I.U.P. showing the success of such transfers.

Upon a motion by Chairman Goodrich, seconded by Senator Chamberlin, thanks was conveyed to members of the Senate who will be leaving the Senate as of September, 1974.

Senator Hazley, Acting Chairman of Committee A (Rules), reported that the following dates have been set for meetings of the Senate during the 1974-75 academic year: September 24, October 8, November 12, December 10, January 21, February 4, March 4, April 15 and May 6.

Senator Hazley moved the adoption of the following plan in order that the Senate may function during the summer interim if necessary: "The Chairman of the Senate may convene that body during the summer session when he feels that there is necessary business to transact. For the summer session 45 members shall be considered a quorum. Any business transacted during the summer shall be subject to the review and approval of the regular Senate at its first regularly scheduled meeting in the fall." The motion was seconded by Senator Lucker and passed. Senator Strawcutter, Chairman of Committee B₁ (Academic Procedures) made the following announcements:

- a. In keeping with interim Senate approval, Committee B₁ recommended directly to Dr. Hassler that four honorary doctorates be awarded during the centennial year, 1974-75. Ranked lists of nationally and regionally known persons were also forwarded. The Committee recommended that degrees be granted to two national and two regional "figures".
- b. Committee B_1 again reminds the faculty that recommendations for emeritus status for retiring colleagues originate with individual departments or administrative units. Recommendations with documentation should be sent to the Committee B_1 Chairman.

Upon a motion by Senator Strawcutter, seconded by Senator Dietrich, the Senate increased the QPA for Dean's List honors to 3.25 (to be consistent with minimum graduation honors).

Senator Strawcutter moved, Senator Lucker seconded, and the Senate passed the recommendation that each department make freely available through its secretary, for student use at the site, a notebook of information about the courses offered in that department. The information should be kept current and as complete as possible. (Committee B₁ recognizes that departmental and professorial planning require flexibility and that the differing nature of courses dictates differing descriptions.) Subject to these constraints, a given course write-up might include: information content outline, major activities such as term papers, trips, seminars, etc.; the bases of student evaluation; major objectives of course; text material, and so on; and the recommendation that University catalogues include the following statement preceding each department's course descriptions: "Further information about courses can be obtained at the departmental office."

Upon a motion by Senator Strawcutter, seconded by Senator Chamberlin, the Senate approved the following change in the readmission policy for the undergraduate catalogue:

> Freshmen entering the University after June 1, 1971, must have attained a 1.8 cumulative quality point average upon the completion of their first full-time academic year to remain at the University and then must maintain a cumulative quality point average of 2.0 for the remainder of the undergraduate career to remain in academic good standing.

If academic good standing is not maintained at the end of a spring semester, the student may use Pre and Main Summer Sessions to obtain the necessary cumulative QPA and avoid dismissal from the University. If the required cumulative QPA is not obtained until the end of the Post Summer Session, the student will be dismissed for the fall semester but may apply for readmission (by the set deadline) for the following spring semester. If the student does not achieve academic good standing by the end of the summer sessions, he may not attend the University for the ensuing academic year. Returning students who first entered the University before June 1, 1971, and who are classified as freshmen or sophomores, should consult the Dean of their school concerning their academic good standing requirements. 3

Senator Fornear, of the Music Department, read a statement of tribute to Dr. Harold S. Orendorff, past Chairman of the Music Department and past Dean of the School of Fine Arts, who passed away recently.

Schator Eisen, Chairman of Committee B2 (Curriculum) reported that the Committee has chosen to delay action on the General Education Proposal until fall. Two reasons for this decision were that there was not sufficient time since the March 26 Senate meeting, because of the Easter break, for faculty discussion on the matter; and the feeling that there was undue haste in bringing the matter to a vote. Therefore, additional work will be done on the proposal by the Committee before the first meeting of the full Senate in the fall.

Upon a motion by Senator Eisen, seconded by Senator Chamberlin, the Senate adopted the following:

- Safety Science 303: Control of Occupational Health Hazards 3 s.h.
 A course teaching the theory and design of systems used in the control of occupational health hazards. Emphasis will be on local exhaust ventilation systems, but dilution ventilation, heat control, lighting and control of electro-magnetic radiation hazards will also be covered.
- 2) Political Science 362: American Political Thought 3 s.h.
 A study of American political thinkers from the Puritans through the current Afro-American writers.
- 3) Spanish 254: Commercial Spanish 3 s.h.
 French 254: Commercial French 3 s.h.
 To prepare students of French/Spanish for employment opportunities in business and commercial positions by practice with commercial letter writing, the use of technical business terms, a survey of special business practices and methods of the French/Spanish commercial systems, and problems of translation.
- 4) IUP Aquatic School Program

HPE 266: Basic Small Craft - 1 s.h.

An activity course designed to introduce the use of the canoe, paddleboard, and sailboat. Emphasis is placed on development of boating skills, safety, rescue, and survival procedures. Red Cross small craft certification is granted upon successful completion of the course. HPE 270: Instructor of Swimming for the Handicapped - 1 s.h. An activity course concerned with the skills needed to teach exceptional children with all manner of handicaps, appropriate not only for physical education but also for education of the mentally retarded, for rehabilitation education, for agency personnel, post graduate swimming education and for a variety of applications in community, social and industrial programs. Red Cross certification Instructor of Swimming for the Handicapped is awarded upon successful completion of the course.

- HPE 271: Instructor of Scuba Diving 3 s.h. A methods course to prepare instructors to teach skin and scuba diving. Instructor of Scuba Diving certificate granted by the Professional Association of Diving Instructors upon successful completion of the course.
- HPE 272: Instructor of Canoeing 1 s.h. A methods course concerned with skills pertinent to teaching canoeing to beginners. All aspects of canoeing including paddling, repair of equipment, white water canoeing, safety and survival are presented. Red Cross certification Canoeing Instructor is granted upon successful completion of the course.
- HPE 273: Instructor of Sailing 1 s.h. A methods course teaching skills needed to instruct beginning sailing, including elements of sailing, repair of equipment, racing and safety.
- HPE 276: Coaching of Swimming, Diving and Water Polo 2 s.h. A lecture/discussion methods course designed to prepare physical education majors to coach swimming, diving and water polo. Emphasis on training methods, officiating, nutrition, scientific principles, and meet and game strategy.
- HPE 277: Advanced Synchronized Swimming 2 s.h. A methods course going beyond the activity nature of Basic Synchronized Swimming (HPE 267), involving set design, costumes, music, props, and organizing the program.
- HPE 279: Swimming Pool Maintenance and Chemistry 2 s.h. A lecture/discussion course teaching fundamental water chemistry, filtration, treatment of water problems, winterization of outdoor pools and pool management. Emphasis is placed on the analysis of the chemical and bacteria content of water.
- 5) EN 260 English Authors to the Restoration 3 s.h.
 EN 261 English Authors from the Restoration to 1900 3 s.h.
- 6) PY 101 Physics and Our Environment 3 s.h.

Senator Chamberlin seconded the motion and it passed the Senate.

Senator Landon, Chairman of Committee F_2 (Athletic Policy) moved the adoption of the following guidelines for post-season competition for intercollegiate varsity teams:

- In order to be eligible for national tournament competition, teams and individuals must qualify through placing in District, Area, or PSCAC competition as specified for each sport and/or through meeting national qualifying standards as required for each sport.
- 2. Teams or individuals who qualify shall be eligible to attend only one national post-season tournament. Any requests for exceptions to this policy must be presented to the Committee on Athletic Policy (Committee F₂) of the University Senate, which will have the final decision in the matter. The motion was seconded by Senator Podbielski and passed.

Senator Dietrich moved to remove from the table (action taken at the March 26, 1974 meeting) the matter of the establishment by the Senate of an ad hoc committee to formulate plans for the implementation of interdisciplinary programs. The motion was seconded by Senator Price, but failed to pass the Senate by a vote of 15 for and 33 against.

Under New Business, President Hassler's request that the Senate appoint or elect a representative of the Senate to the I.U.P. Human Relations Committee was delayed until the next meeting of the regular Senate since a quorum was no longer present. Senator Dietrich and Senator Einsporn, members of the Ad Hoc Committee on the Relationship between APSCUF-PAHE and the University Senate, announced that a meeting of that committee would be held at 2:00 p.m. on Friday, May 3, 1974 in the Student Government Association office, to respond to a statement on faculty unionism which originated in the Student Government Association. This committee was established to determine what effect, if any, has been made on the fulfillment of the University mission by the recent events surrounding the fiscal difficulties, and to determine what feasible relationship exists between the bargaining unit and the Senate.

Distributed at the meeting was the proposed calendar for the 1975-76 academic year (copy attached). Comments concerning this proposed calendar are to be forwarded to Dr. Wayne J. Davis by July 1, 1974.

The results of the election of one University Senate officer and the election of committee members are shown on the following three pages.

Upon a motion by Senator Lucker, seconded by Senator Bright, the election of a Senator-at-Large to Committee B_1 was deferred until the first meeting of the full Senate in the fall.

The meeting was adjourned at 5:50 p.m.
