#### MINUTES OF THE UNIVERSITY SENATE

The May 6, 1975 meeting of the University Senate was called to order at 3:30 p.m. in Pratt Auditorium by Chairman Thomas Goodrich.

The following Senators were absent but accounted for: Cashdollar, Ferguson, Ferrara, Hadley, Johnson, Jones, Montgomery, Murdoch and Whyte.

Upon a motion by Senator Chamberlin, seconded by Senator Lanham, the minutes of the April 15 meeting were approved as published.

Chairman Goodrich announced that he had relayed the Senate position on the makeup of the Presidential Selection Committee to the Board of Trustees—without success; and indicated that there is to be an effort made at the Board meeting on May 9, 1975 to alter the number of members on the Presidential Selection Committee, as well as to alter the proportions of the various constituencies, and particularly to increase the number of students on the Committee.

Chairman Goodrich moved that the Senate indicate its approval of the additional membership on the Presidential Selection Committee, with the concept that for each additional member of the student body added to the committee, both undergraduate and graduate, that there be an additional faculty member added to that Selection Committee. The motion was seconded by Senator Chu.

Senator Hassler suggested that consideration be given to including AFSCME representation on the Presidential Selection Committee. Senator Warren so moved and Senator Kolaczkowski seconded that the Senate indicate its support of AFSCME representation on the Presidential Selection Committee. This amendment to the original motion by Chairman Goodrich was approved.

The motion to approve additional student representation, additional faculty representation, and AFSCME representation was then passed by the Senate.

Chairman Goodrich reminisced about some of his feelings concerning the functions of the Senate and some of the aspects which the Senate might have dealt with—including money and admissions. He expressed hope and optimism that in the future the Senate will be able to strengthen itself in its present activities and take up new responsibilities.

100 July & 15 July 1

Chairman Goodrich shared with the Senate the following verse which he observed as an undergraduate student in his college dormitory:

"Climb high
Climb far
Your goal-the sky
Your aim-the stars."

Chairman Goodrich indicated that, as Senators, we can keep a view of these fardistant aspirations that afflict so many of us in education.

Chairman Goodrich expressed the thanks and appreciation of the Senate to Dr. William W. Hassler, President of the University, for his support of the Senate, in so many ways, and wished him Godspeed where he is going.

Senator Lehman, of Committee A (Rules) announced that, in error, three persons had been elected to serve on Committee D (Graduate) at the April 29 meeting of the Senate. Therefore, John Broughton will not be serving as a member of Committee D, as only two vacancies were to be filled.

Senator Gallanar, Chairman of the Ad Hoc Committee on the Pennsylvania Commonwealth University Bill, reopened discussion on his motion to reject the concept of the PCU Bill (carried over from the April 29 meeting). It was pointed out by various members of the Senate that actually we now are operating under this concept-without the name, without the chancellor, without the possible safeguardsthat I.U.P. and the 13 state colleges are operating as one unified collection of schools and that basically what this Bill would do would be to transfer the stateowned institutions out of the Pennsylvania Department of Education and into the office of a Chancellor and a Board of Regents, providing for more centralized control.

Senator Tompkins moved that the original motion be amended to include a definition of the concept of the Pennsylvania Commonwealth University Bill; i. e., that the 13 state colleges and I.U.P. shall be managed and administered by a Chancellor and Board separate from the Pennsylvania Department of Education. amendment was seconded by Senator Chamberlin and carried by a vote of 54 Yes, 15 No.

Following further discussion on the concept, provisions, and different interpretations of the Bill, debate was closed following a motion by Senator Lentz, seconded by Senator Hisiro.

The amended motion, as presented by Senator Tompkins and seconded by Senator Chamberlin, was defeated by a majority vote.

Senator Gallanar then moved to accept the modifications of the PCU Bill, as outlined in the Ad Hoc Committee Report, as follows:

# Senate Bill No. 224, Session of 1975:

- 1. 2002A p. 4, lines 9-12. Substitute the following wording: "Each of the institutions shall retain their present name and shall be elevated to university status by following the established and statutory requirements.
- 2. 2004A pp. 5-6. Concern was expressed regarding the make-up of the proposed Board of Regents especially as it related to the selection process. Less emphasis should be given to political appointments and more emphasis should be given to the appointment of individuals qualified to serve on educational decision making boards.

- 2. Committee A is discussing the possibility of holding a forum for open discussion on the future goals and direction of this University. Any responses or ideas concerning this forum will be welcome.
- 3. Committee A3 has received a great response to the revision of the University Senate constitution and by-laws and are currently working on this revision.

Senator Gray, Chairman of Committee  $B_1$  (Academic Procedures) presented the following for Senate information:

- Committee B<sub>1</sub> enderses the credit courses program in principle as presented in the Proposal, subject to the condition that as implementation progresses administrative details will be considered by the appropriate University Committees and/or administrative offices.
- 2. Information about the credit courses program is available in the School of Continuing Education, 773 Locust Street. You can see it there. In addition, the Board of Trustees, the President, all Vice Presidents, all Deans and Associate Deans, all Directors, and all Department Chairmen have copies.

Senator Gray moved that D and F reports be required only for full-time freshmen, and be optional for other students at the discretion of the instructor, with the recommendation that the D and F reporting period should begin immediately after the end of the discrete course withdrawal policy. The motion was seconded by Senator Buterbaugh and passed by the Senate.

Senator Gray moved that the semester hour requirement for inclusion on the Dean's List be 12 semester hours, exclusive of Pass/Fail hours. The motion was seconded by Senator Tobin and passed by the Senate.

The motion was seconded by Senator Eddy and passed by the Senate.

Senator Tompkins, Chairman of Committee B2 (Curricula) announced that the list of undergraduate courses for which no record of proper Senate and Board approval is at hand is not yet available. He also made the following corrections and changes in the list of courses submitted for Senate approval:

FL 485 - SELF INSTRUCTION IN CRITICAL LANGUAGES - add "3 cr"

FN 356 - FOOD SERVICE PLANNING AND ADMINISTRATION should be FOOD SERVICE PERSONNEL AND ADMINISTRATION

EN 100 - BASIC ENGLISH (3 cr) should be substituted with
EN 325 - PUBLIC RELATIONS - PRINCIPLES AND PRACTICES (3 cr)

Senator Tompkins also announced that it was the consensus of Committee  $B_2$  that the motion for proposed revision of the General Education Program should be renewed at this time.

Senator Landon called for the order of the day and Senator Tompkins ruled that the orders of the day are for Committee  $B_2$ 's report and that this is in order, and if the assembly wishes to upset that, he would entertain an appeal. Senator Landon appealed Senator Tompkins' ruling.

Senator Bright asked if Chairman Goodrich had formally relinquished the Chair. Chairman Goodrich replied that it had always been an informal relationship and unless there is a problem of complexity, the problem is that normally someone else handles the Chair. Senator Bright indicated that he felt the complexity was at hand since it was a parliamentary motion.

Chairman Goodrich then ruled that the orders of the day included the report of Committee B2 and that there seemed to be no motion on the floor.

The parliamentarian stated that the motion which called for the orders of the day is a privileged motion and so former practice does not apply.

The Chair ruled that the printed agenda is the order of the day.

Senator Phelps appealed the ruling of the Chair, seconded by Senator Brown, which was defeated by a vote of 25 Yes, 45 No and 1 Abstention.

Senator Tompkins then moved approval of the following:

- 9. FN 408 SCHOOL FOOD SERVICE MANAGEMENT (3 cr)

The motion for approval of these courses was seconded by Senator Chamberlin.

Senator Angelo moved an amendment to Senator Tompkins' motion to substitute the word PERSONNEL for the word PLANNING in FN 365 - FOOD SERVICE PERSONNEL AND ADMINISTRATION (3 cr). The amendment was seconded by Senator Shawer and passed by the Senate.

Senator Phelps moved an amendment to include EN 525 - PUBLIC RELATIONS: PRINCIPLES AND PRACTICES (3 cr) in the course list as a substitute for EN 100. The motion was seconded by Senator Buterbaugh and passed by the Senate.

Senator Phelps moved an amendment to insert (3 cr) following FL 485 = SELF-INSTRUCTION IN CRITICAL LANGUAGES. The amendment was seconded by Senator Landon and passed by the Senate.

The Senate then passed the courses listed (1-9), with the addition of FN 365 - FOOD SERVICE PERSONNEL AND ADMINISTRATION (3 cr) and EN 525 - PUBLIC RELATIONS: PRINCIPLES AND PRACTICES (3 cr) and the addition of (3 cr) to FL 485.

The meeting was recessed at 5:30 p.m. due to the lack of a quorum and will be reconvened at 3:15 p.m. on Thursday, May 8, 1975.

Senator Tompkins moved approval of the following substantive course and program changes:

- Change the content of the B.A. in Chemistry program, reducing the required Chemistry credits from 39 to 29, and allowing any regularly available foreign language (thus relaxing the previous requirement of German).
- 2. Change the requirements of the Mathematics minor from 18 to 17 credits, with acceptance of any of the available calculus sequences (thus relaxing the previous reauirement of NA 111-113).
- 3. Change of credits of PC 451 PSYCHOLOGY PRACTICUM, from 3 cr (with one repeat possible to a total of 6 cr), to a variable 1-12 cr.
- 4. Change of credits of ED 423 PROFESSIONAL PRACTICUM & SCHOOL LAW (for elementary education majors) from 2 cr to 3 cr, with concomitant increase of the Professional Education component of the Elementary Education major by 1 credit.
- 5. Change of MU 120, 121, ..., 134, the ensemble courses (including band, orchestra, choruses, ...) from O cr to 1 cr, with concomitant change in the requirement for ensembles in music degree programs from 14 to 6 (i.e., from 0 cr to 6 cr), and the inclusion of those 6 cr in the presently elective parts of such programs. Ensemble participation would continue to be available without enrollment in the credit courses for qualified persons not needing or desiring academic credit.

The motion was seconded by Senator Glott and passed by the Senate.

Senator Tompkins moved approval for continuation of temporary approval of CN 302, CAREER PLANNING AND DEVELOPMENT (1 cr) for one year. The motion was seconded by Senator DeFurio and passed by the Senate.

Senator Tompkins moved approval of the following resolution:

"Because there are a number of undergraduate courses being offered for which no record of proper Senate and Board approval is at hand, Committee B2 requests retroactive temporary approval of such courses as have been offered and may be offered in the Fall semester of 1975; further, that such courses should be submitted to Committee Bo for Senate consideration for permanent approval during the Fall of 1975."

(The list of courses affected by this motion will be presented to the Senate when it is complete and correct.)

The motion was seconded by Senator Chamberlin and passed by the Senate.

Senator Tompkins moved approval of the retroactive temporary approval of the increase of LR 301, AUDIO-VISUAL EDUCATION, from 2 cr to 3 cr, with the concomitant increase by 1 credit in the requirement for professional education courses in all programs requiring LR 301. Permanent approval should be sought in the Fall of 1975. This motion was seconded by Senator Price and passed by the Senate.

Senator Tompkins moved for a suspension of the rules in order to bring back to the floor of the Senate the proposed General Education Program. The motion was seconded by Senator Hisiro but failed to get the 2/3 majority vote required to suspend the rules. Official vote was 26 Yes, 31 No.

Senator Gallanar, Chairman of Committee D (Graduate), moved approval of the following:

"The University Senate endorses and supports the principle that the advisement of theses and/or dissertations should be considered part of the teaching load of the faculty member involved."

The motion was seconded by Senator Mott and passed by the Senate.

Upon a motion by Senator Gallanar, seconded by Senator Landon, the following new courses were approved:

BU 535 Management Information Systems - 3 s.h.

BU 543 Management Development and Training - 3 s.h.

Senator Gallanar moved approval of the following title and credit change:

BU 553 Change of title from Administration of Vocational Business Education to Administration and Supervision of Vocational Education, and the change from 2 s.h. to 3 s.h.

The motion was seconded by Senator Landon and passed.

Senator Gallanar moved for the suspension of the rules in order to permit a guest to speak on the next item of business, the proposed D.Ed./Ph.D. Program in Counselor Education. The motion was seconded by Senator DeFurio and passed by the Senate. Dr. Robert Saylor was introduced to the Senators and asked to respond to questions and concerns about the proposed program.

Considerable discussion ensued as to the additional resources (library materials, faculty, assistantships, courses, etc.) required if such a program were approved. Also discussed was the relationship of this program with other departments on campus, enrollment data for the future, costs, and other aspects of the proposed doctoral program.

Senator Eddy called for a quorum count at 5:15 p.m. As no quorum was present, the meeting was adjourned.
