

## MINUTES OF THE UNIVERSITY SENATE

The November 10, 1981 meeting of the University Senate was called to order by Chairman Stanford Tackett at 3:15 p.m., in Pratt Hall Auditorium.

President Worthen read portions of a letter addressed to the Secretary of the Board of Trustees from the Secretary of Education, Robert Scanlon concerning legislative policy directive issued on September 11, 1981. Administrative guidelines are to be drawn up jointly and discussed by the Department of Education officials and the state college and IUP Boards before they are put into effect. Dr. Worthen indicated that he and Dr. Watkins, President of California State College will be meeting with two members of Secretary Scanlon's staff on Monday, November 16, 1981, to begin writing these guidelines..

President Worthen also announced that a meeting has been called by APSCUF for December 3, 1981 to discuss the present status of the SSHE Bill. He indicated that the IUP Board of Trustees have indicated that in order for them to support the SSHE Bill, it must include two elements: 1) that the care, control and governance of the institution remain with the Board of Trustees, not with a state-wide board and chancellor; and 2) that it must include a statement that will refer to and assure that the funds that are allocated will be allocated in a "equitable way"--on the basis of enrollment by program by level. Further details and questions will be explained and discussed at the open meeting on December 3.

The minutes of the October 13, 1981 meeting were approved as published.

The Rules Committee announced the following:

- a. Next Senate Meeting - December 8, 1981 - 3:15 p.m. - Pratt Aud.
- b. Committee A meets the first Tuesday following each Senate Meeting.
- c. Kay Stratton has been appointed to serve on Committee A.

The Rules Committee presented for Senate action a By-law change concerning Committee E - The Committee on Faculty Research, Library and Educational Services. It was pointed out by the Acting Parliamentarian that the present Constitution provides that by-laws can be amended by a simple majority by written ballot. It was moved by Senator Wegener, seconded by Senator Caruso, and passed by the Senate that this rule be suspended so that action could be taken promptly on this matter. Committee E and Subcommittee E1 were then approved, as follows:

Committee E. The Committee on Faculty Research, Library and Educational Services.

1. Function: Committee E shall have general responsibility for the preparation of research reports, provide for the recommendation of faculty research policies and goals and objectives for research to the University Senate. Committee E shall be generally responsible for recommending policies for the imprint series, general policies of the libraries and media resources area, Computer Center, and Printing Center.
2. Membership:
  - a. Appointed: The Director of Institutional Research, the Assistant Dean of the Graduate School, the Director of the Computer Center, and the Director of Libraries and Media Resources shall be members of the Committee E, plus the administrative member of Subcommittee E-1.
  - b. Elected: Eight faculty plus the membership of Subcommittee E-1 and five student members, one of whom shall be a graduate student, shall be elected by and from the members of the University Senate.
3. Officers: A chairman, vice-chairman, and a secretary shall be elected by Committee E from its members.

4. Meetings: Meetings of the Committee shall be open to all members of the University Senate and shall be announced in advance.

E-1. Research Subcommittee of Committee E (herein after known as E-1)

1. Membership:
  - a. Faculty: One faculty member per academic school and one faculty member representing the University Services area. The Graduate School and the School of Continuing Education are excluded from membership.
  - b. Administration: One dean elected from Senate membership.
  - c. Students: No student membership.
  - d. Membership of Subcommittee E-1 constitutes active membership of Committee E.
  - e. Special conditions: Initial Subcommittee membership will include those members currently serving on Committee E who desire to serve on E-1. In the case of two or more faculty members serving on Committee E from the same school, an election within Committee E shall be held to determine the school representative. The balance of the membership of E-1 shall be elected from the Senate during a special election. No Senator whose term expires in May, 1982, may be eligible as a member of E-1. (This provision expires in May, 1983).
2. Election of Subcommittee Membership: Annual election of the faculty members from the University Senate membership shall occur. The first annual election will be held concurrent with the regularly scheduled Senate elections in 1983. The four faculty members with the highest number of votes shall serve a two year term and the next four faculty members shall serve a one year term.
3. Officers: A chairman, vice chairman, and secretary shall be elected by Subcommittee E-1 from its members.
4. Function: To receive the ranked research proposal from the school research committees. The Subcommittee must abide by the rank order set by a school committee. The Subcommittee then recommends rank order of funding of research proposals on a University-wide basis. It is not mandatory that a proposal from each school be selected. These recommendations shall be forwarded directly to the University President for consideration. The Subcommittee shall report to Committee E and the Senate for information only. The Subcommittee shall advise Committee E on all matters related to research, the implication of research, and the needs to meet changing trends in research.

As recommended by Committee B2, Curriculum, chaired by Senator K. Jones, the following new courses were approved:

SPECIAL EDUCATION:

- a. EX 464 - Preschool Education of the Handicapped (3 s.h.)  
Preschool education of the handicapped will provide information on development of intervention strategies, assessment of prescriptive planning for, and curricular programs for the preschool aged handicapped child from infancy to five years of age. This course will fulfill a need for preparing needed teachers for preschool programs for the handicapped. This would also satisfy state and federal priorities where the emphasis is being placed for the education of preschool handicapped.
- b. EX 251 - Methods of Teaching Reading (3 s.h.)  
Objectives, background knowledge and understandings of developmental reading processes, an overview of elementary program, pre-adolescent and their needs in reading, finding and providing for instructional needs, and special problems.
- c. EX 490 - Ethical and Professional Responsibilities (1 s.h.)  
Responsibilities during professional laboratory experiences are included. Rights and responsibilities in relation to current legislation will be discussed. Possibilities for and methods of instigating and profiting from post-baccalaureate study are indicated.

ADMINISTRATIVE SERVICES AND BUSINESS EDUCATION

- d. AD 430 - Offices Systems (3 s.h.)  
A course primarily for the Office Administration major that integrates the concepts of the various courses in the administrative services area. Prerequisite: FS 240 - Introduction to Management Information Systems; AD 412 - Administrative Office Services; AD 472 - Introduction to Word Processing; and AD 415 - Records Administration.

FOREIGN LANGUAGES (French)

- e. FR 255 - The Art of Translation (Version) (3 s.h.)  
Practice in the skills needed to translate from the foreign language into English. Students will analyze problems of translation as they occur in scientific, business, journalistic, and literary texts. Prerequisite: FR 252 or its equivalent.

The following five program revisions were approved, on Committee B2's recommendation:

- a. CONSUMER SERVICES

Clothing, Textiles, Interior Design option reorganized into three major areas of study: (1) Fashion Merchandising, (2) Interior Design/Housing, and (3) Consumer Affairs. The courses required for the proposed majors are similar to the current program, as indicated on the following page:

Additional funding is desperately needed because of the tremendous expense in getting the Library moved.
2. The Library has educational films available and urges faculty to use these as much as possible.
3. The new library facilities are being used greatly and in some respects is already too crowded.

## DISTINGUISHED ACHIEVER SCHOLARSHIP PROGRAM

In order to stimulate outstanding students to apply and matriculate to IUP, the Distinguished Achiever Scholarship Program is established. Scholarship recipients will receive \$1,000 annually for four consecutive years. Approximately fifteen Distinguished Achiever Scholars will be named each year at an annual cost of \$15,000. Total cost of the program after the fourth year will be \$60,000. The program will be funded through the IUP Foundation's Annual Fund Campaign.

### Criteria for Selection:

1. Students must demonstrate outstanding achievement in one or more of the following areas: school or community leadership, entrepreneurship, music, art, dance, theatre, forensics, or other related areas.
2. Students must rank in the top tenth of their class at the end of the junior year and/or have scored 1100 on their junior SAT or ACT equivalent.
3. Students should be nominated by one of the following people: high school guidance counselor, an IUP faculty member, IUP alumnus, high school teacher or community leader.

## POLICIES AND PROCEDURES

- A. Selection - The University Selection Committee shall be composed of the following representatives:
  1. Academic Dean or Associate Dean selected by the Dean's Council
  2. A representative of the University Financial Aid Committee selected by the Committee
  3. An Admissions office staff member
  4. A Financial Aid office staff member
  5. Two faculty members appointed by the University Senate
  6. Two students appointed by the University Senate
- B. The committee will begin reviewing applications on December 1st of each year and must complete its work no later than January 25.
- C. The committee shall develop a method of reviewing applications for the award utilizing the criteria for selection listed below:
  1. Students must demonstrate outstanding achievement in one or more of the following areas; school or community leadership, entrepreneurship, music, art, dance, tneatre, forensics or other related areas.

2. Students must rank in the top tenth of their class at the end of their junior year and/or have scored 1100 on their junior SAT or ACT equivalent.
- D. Scholarship Awards - Each student will receive a \$1,000 Scholarship to be paid in the amount of \$500 for each semester during the academic year. The following policies govern the renewal of the scholarship:
1. A recipient must have a 3.0 cumulative grade point average at the end of the main summer session and have completed 24 credits prior to beginning of the following year.
  2. If a student does not have a 3.0 cumulative grade point average, he/she will be ineligible to receive the scholarship award for the year. However, if by the end of the main session of the next year the student achieves a 3.0 cumulative grade point average, he/she will be eligible to receive the \$1,000 scholarship for the following year.
  3. Students that accelerate their academic career will not be eligible for more than \$1,000 per year. No awards will be paid once students complete their undergraduate careers.
- E. Recipients of the scholarship will be expected to contribute up to 20 hours of service to the University each semester. The assignment of service opportunities will be completed by the Office of Admissions. The types of service opportunities for which scholars will be eligible are as follows:
1. Serving as hosts at special University functions to include Open House, Guidance Counselor Articulation Days, Interview Orientation Days, and related activities sponsored by the Admissions Office.
  2. Assisting at official University functions sponsored through the Office of Public Relations.
  3. Representing the University at special programs such as displays and shopping centers and convention expositions or related areas.
  4. Service to the University Museum.
  5. Providing assistance to the Department Chair in their academic major.

The office to whom the student is assigned shall be responsible for recording the hours completed by the student.
