## RULES COMMITTEE, CHAIRPERSON TACKETT

The following recommendation from the Rules Committee was APPROVED:
Terms of service for those elected to standing committees is 2 years, with one-half to be elected each year. Two committee memberships (Graduate and Undergraduate Curriculum) has changed over the years so that more than half of the membership must be elected one year, and less than half of the membership must be elected the next year. The Rules Committee moves that permission be granted to adjust the committee terms for the Graduate Committee members elected this year so that 5 members are elected to 2 -ytar terms and the 6 th member is elected to a I -year term. The Undergraduate Curriculum Committee terms will need to be corrected next year since onty 1 - a $-1-$ vacancy occurs this year. Understood is the need for the Rules Committee to be more diligent in its future record keeping.

In the program revision proposal for Bachelor of Science in Education--Social Science Education/History Track (page 8, item b), the following (bolded) statement should be inserted immediately after the string, "As outlined in Liberal Studies section with the following specifications:" Humanities/History Fulfilled by History Sequence in Major.
4. Delete the following paragraph which appears at the top of page 9:
"Note: This program replaces all previous secondary social studies teacher certification plans effective Fall 1992. Students currently completing prior prggrams may elect to (a) remain in those programs or (b) change to the plan described above. All entering students, whether from intemal or external transfer or post-baccalaureate, must follow the above program or the revised programs in sociology or geography."

An integrative course in Human Resource Management. Considers current issues in human literature in the field and contemporary issues in human resource management using case studies.

Bachelor of Arts with tracks in either Art History or Art Studio, the Bachelor of Fine Arts in Art Studio, and the Bachelor of Science in Education in Art Education. The degree in art education provides certification for teaching art in grades $\mathrm{K}-12$ in the schools of Pennsylvania.

The Department of Art offers a cooperative program with the Art Institute of Pittsburgh. Students interested in commercial art, with departmental approval, may earn credit to ward their major at the Art Institute. A cooperative program in metals is available at the Bowman Technical School, Lancaster, Pennsylvania.

All art majors are obligated to fulfill the university requirements for Liberal Studies. The Department of Art expects that art majors will maintain a 2.5 average in major courses, and this will be a prerequisite to student teaching.

A minor in art is available, consisting of at least 15 semester hours in art courses approved by the chairperson of the Department of Art.

## 6. Change in College Requirement:

The proposed curriculum change would result in the following catalog change. The current description of the foreign language requirement, which now appears in the catalog section describing the College of Natural Science \& Mathematics (see 1990-91 Catalog, page 88), will be moved, unchanged, into the sections describing each individual department. The foreign language requirement as currently stated in the catalog will no longer appear in the description of the College of Natural Science \& Mathematics. For each of the college's departments (Biology, Chemistry, Computer Science, Geoscience, Mathematics, Physics, and Psychology) and for the Natural Sciences program there will be a foreign language requirement identical to that which now is a college-wide requirement.

## GRADUATE COMMITTEE, CHAIRPERSON NASTASE

The following recommendations from the Graduate Committee were APPROVED:

1. Change in prerequisites for Economics course EC 634:

Old Program

EC 501 or EC 121 and EC 122
EC 121, EC 122, MA 121 or equivalent
EC 501 Foundations of Modern Economics is no longer offered. A knowledge of first year calculus is necessary to understand the course material.

The catalog will continue to state that prerequisites may be waived for particular students by permission of the instructor.

## 2. New Course:

EN 760 Teaching College Literature 3c-01-3sh
Examines current research on teaching college literature, and involves ongoing observation and practice of teaching strategies. Special attention is given to the impact of critical theory and such issues as canon, race, class, and gender in specific classroom settings.

At 4:50, while the Senate was acting on a new course proposal for HP 650 Wellness - A classroom Approach, a hand-count of votes ( 51 in favor, 15 opposed, and 7 abstentions) revealed a lack of quorum; the meeting was therefore adjourned until September 10, 1991.

The Operating Principles for Campus Governance and Senate Re-Organization (refer to Attachment F, September 10, 1991 Agenda) was presented for Senate deliberation. The proposal will be brought before the October Senate meeting for a vote.

Senator Begg read the Resolution submitted as Attachment A to the Senate. The Resolution was APPROVED by the Senate.
