MINUTES OF THE UNIVERSITY SENATE

The February 4, 1992 meeting of the University Senate was called to order by Chairperson Ron Juliette at 3:15 p.m. in McVitty Auditorium.

The December 10, 1991 minutes were amended by deleting Senator Noel's name from the list of absent Senators. In addition, the names of Senators Dugan and Williamson were moved from the 'absent' list to the 'excused' list.

The minutes were then APPROVED as amended.

The agenda items and order were APPROVED as submitted.

Chairperson Juliette made the following announcements:

- 1. We have no recording secretary. Yaw Asamoah will do the best he can to take notes on the proceedings, but, until we find a new recording secretary, the minutes will not be as thorough as it has been.
- 2. Dr. Fuget is creating a Capital Campaign Commission that will, among other things, prepare a preliminary draft of an institutional needs list, determine the cost of conducting a capital campaign, and prepare a tentative timetable for conducting the campaign. He has asked the Senate to appoint three senators, one from each segment, to the commission. All interested Senators should please contact me by Friday, February 7.
- 3. The ballot for the Senate response to the Cost Reduction Proposal was analyzed and forwarded to Dr. Fuget prior to the December Council of Trustees meeting. Although the summary report was not distributed to every Senator because of the expense of reproducing the 14-page document, each Senate chair was given a copy; in addition, two copies of the document are available at the reserve desk in the library.
- 4. Finally, I would like to recognize a former Senator for his contributions to the University Senate. Chris Knowlton, who was the Executive Director of the Student Cooperative Association until his retirement in December, was the only person on campus who held continuous membership in the University Senate since its founding in 1971. On behalf of the Senate I would like the minutes to acknowledge our appreciation for his dedicated support to university governance and the Senate, to thank him for his many contributions to the Senate, and to wish him well in his retirement.

STANDING COMMITTEE REPORTS

RULES COMMITTEE, CHAIRPERSON STINEMAN

1. Proposed Changes in the Senate Constitution

The Committee submitted copies of a draft of the Constitution for Senate information. This draft reflects the changes recommended in the Constitution by the Ad-Hoc Senate Advisory Committee and approved by the Senate at its October and December 1991 meetings. The first reading of the draft is scheduled for the next meeting of the Senate.

2. Forthcoming Senate Elections

The Committee plans to conduct elections in April to replace those Senators whose terms expire in May. All eligible members of the University community are urged to consider running for a senate seat.

3. Re-organization of Senate Committees

The Committee has been asked to examine the functions of each Senate Committee and to consider re-organizing the Committees in order to devise a more equal distribution of duties. In order to accomplish this, the Committee has

invited the Chairperson of the Senate and all committee chairs to attend the Rules Committee Meeting on March 17, in 2B Uhler Hall. Each Committee chair will be asked to provide his or her committee's job description. Chairs who cannot attend are urged to send a committee representative.

Gerontology Certificate Program

The Gerontology Certificate program provides an interdisciplinary approach to the systematic study of aging and is designed to be combined with any undergraduate major at IUP. The 21 credit hour program entails three core courses, three elective courses, and an internship that will provide experiential learning in an agency or program serving older adults. - 4. The Senate also considered four program revision proposals and took the following actions:
 - a. Bachelor of Science--Chemistry (see page 6 of the February 4 agenda).

As moved by the Committee, the Senate <u>APPROVED</u> the proposal (i) to add CH 410 Advanced Inorganic Chemistry Lab (a requirement for American Society certification) to the required courses for the Bachelor of Science--Chemistry degree, and (ii) to reduce the Controlled Electives requirement by 1sh.

b. Bachelor of Science Programs in Business (see page 6 of the February 4 agenda)4.

Upon the Committee's recommendation, the Senate <u>APPROVED</u> the replacement of IM 241 Introduction to Management Information Systems with IM 300 Information Systems: Theory and Practice, in all the bachelors degree programs offered by the College of Business.

(4) The list of programs affected by this action was amended by changing the entry "Bachelor of Science - Office Administration" to read: "Bachelor of Science - Office Systems."

UNIVERSITY COMMITTEE REPORTS

A. AD-HOC COMMITTEE ON TEXTBOOKS AND COURSE FEE POLICIES, CHAIRPERSON NOWELL

The Senate considered the background information and motions submitted by the Committee (see pages 7-10 of the February 4 Agenda). During the lengthy debate that ensued, the following actions were taken:

An Ali motion to table the motions until the issues raised by the Committee were resolved at a State-Level Meet-and-Discuss was DEFEATED.

A Cunningham motion to return Motion I to the Committee for re-wording was APPROVED.

Motion II was amended to read as follows:

IUP policy is that textbooks, media materials, computer programs, and other materials which are adopted for courses at IUP by faculty, and which are required to be purchased by students, should be selected based upon the quality and appropriateness of the material. Faculty members or any department of the university should therefore avoid the solicitation of or the acceptance of any types of fees, rebates, cash grants, allowances, or any other services as an inducement to adopt a particular text or other material for a course.

This statement should not be interpreted as precluding the acceptance of a free desk copy of an adopted text or supplementary instructional materials designed for use with that text. Furthermore, faculty are allowed to accept other textbooks and related media from publishers as long as such acceptance is not related to the adoption of a textbook or other course materials.

(Note: This last paragraph recognizes the difference between a publisher sending free materials to a faculty member to encourage the faculty to consider those materials or to recommend the materials to other faculty members, and the promising of various materials by a publisher in return for the adoption of a specific text.)

The motion was then APPROVED.

At this point, a motion was made and seconded to extend the meeting for 10 minutes. The motion was APPROVED.

The Senate APPROVED a Cashdollar motion to return Motion III to the Committee for re-writing.

The meeting was adjourned at 5:10 p.m.
