University Senate Minutes

October 4, 2022 3:45pm - 5:00pm, Eberly Auditorium

 Chairperson Piper called the October 4, 2022 meeting of the University Senate to order at 3:45pm

- Minutes from the September 6, 2022 meeting were <u>APPROVED</u>
- Agenda items for the October 4, 2022 meeting were APPROVED with the following revision:

Reports and Announcements

A. President's Report:

- O We had a great Family Weekend followed by a great Homecoming. For Homecoming, our Indiana Area Collaborative Team (I-ACT) partners we out in force. There was a significant increase in overall traffic through the community that increased the number of police calls, but with few serious situations. Pennsylvania State Police dealt with two more serious situations, neither of which involved IUP students, but involving drugs and weapons. We are thankful for law enforcement and first responders keeping us safe every day of the year. Thursday night's rap concert went very well, with no concerns. The same is true for the Tuesday and Thursday concerts featuring Maestro Leonard Slatkin and Dr. Cindy McTee, this year's Edward R. Sims Distinguished Artists, who worked with our music faculty and students. On Saturday, the rain stopped long enough for a parade featuring 85 units, including "The Legend," IUP's Marching Band, and four Superhero floats by IUP fraternities and sororities. The Crimson Huddle that followed had almost 800 participants. IUP Football beat Slippery Rock in a game that turned very wet at halftime right when Dr. Segar and I were recognizing the latest Crimson Court students and the float prize sponsors. Saturday evening, IUP Women's Field Hockey defeated Mansfield. And on Sunday morning, IUP students were out cleaning up the streets.
- Yesterday, IUP issued its press release summarizing fall enrollment. Overall head count was down to 8832, while new, first year students were up by more than 4 percent reversing the five-year decline. We were also up in enrollment in career preparation programs Criminal Justice Training Center, Academy of Culinary Arts, paramedic, and the like. We saw a two-percent increase in international students. About 19 percent or our students (nearly 2000 students) identify themselves as minority. Overall, 27 percent of our students are international or minority students. You can read more in the press release, which is on IUP's News webpage.
- Finally, congratulations to all those involved in seeking and getting grants. Awards include about \$1M from the regional Build Back Better EDA grant and the largest grant in IUP's history, an initial \$4.5M in cybersecurity secured by Dr. Waleed Farag.

B. Provost's Report:

- o I have a few good news announcements.
- The third and final candidate for the Eberly College of Business dean search is here today. The search committee will conclude its work later this week. The College of Education and Communications and the Kopchick College of Natural Sciences and Mathematics deans' searches will begin soon. The chair of the College of Education and Communications search is Curt Scheib and the chair of the Kopchick College of Natural Sciences and Mathematics search is Hilliary Creely.
- We will be launching six tenure track faculty searches soon. These positions are in Nursing,
 Psychology, Special Education, and Computer Science. We are pleased to have new colleagues joining us for the next academic year.
- Lastly, we are gearing up for Middle States. We are in the beginning of our process, with the self-study to be submitted in 2024-2025. The co-chairs are Edel Reilly and Paula Stossel. An additional eight committee members are attending the MSCHE Self-Study Planning Institute.
 We will be asking for additional volunteers for the Middle States' standards committees. We are looking forward to engaging in this process.

Interim Chair Decker brought forth the following bylaw amendment for a *First Reading*. A Senator questioned if the *First Reading* should be brought forward since it was not on the agenda that was distributed to Senators on September 27, 2022 nor was it added to the agenda at the beginning of the meeting. A motion was made to postpone the *First Reading*, discussion ensued, and a hand vote occurred. The motion was denied. There were several Senators who voiced concern about having Senate meetings via Zoom; others were in support of the bylaw change. The vote to amend the bylaws will occur at our next meeting on November 1, 2022.

Rationale for proposed bylaw amendment

The rules committee was charge with proposing changes to the bylaws to permit electronic meetings. The existing bylaws permit an asynchronous electronic meeting limited specifically to the approval of minutes of the last scheduled University Senate meeting of the academic year. The Rules Committee proposes maintaining the existing language of bylaw I. D. but moving it into the second part of bylaw that covers electronic meetings as a general topic. New D. 1. Contains proposed language authorizing electronic meetings for the University Senate and its committees. The existing asynchronous meeting language will become new paragraph D. 2. The words in red are the proposed changes

Current:

UNIVERSITY SENATE BYLAWS

I. Meetings

A. The University Senate shall hold at least four monthly meetings per academic semester, excluding the summer sessions, at a time and place indicated by the presiding officer. Additional meetings may be called at the discretion of the chair, or upon petition by one-third of the University Senate membership to the Rules Committee, which shall establish a date and place and publish the reason for such a meeting within two days of the date such a petition is received.

- B. No meeting of the University Senate shall be held when the university is not officially in session.
- C. The chair of the University Senate may convene that body during the summer session when there is necessary business to transact. For the summer session, 45 members shall be considered a quorum. Any business transaction during the summer shall be subject to the review and approval of the regular University Senate at its first scheduled meeting in the fall.
- D. Following the last scheduled University Senate meeting of the academic year, an electronic asynchronous meeting will be held to review and approve the minutes from the previous meeting. The minutes will be distributed to senators electronically. Any

comments, corrections, or concerns that a senator has regarding the minutes can be expressed electronically so that all senators will receive the posting. At least two business days following the posting of the minutes, the chair of the University Senate will call for a vote and provide an electronic link where senators can vote. At least one business day will be provided for senators to vote to approve or not approve the meeting minutes. Once tallied, senators and other interested entities will be informed of the outcome.

Proposed Revision

UNIVERSITY SENATE BYLAWS

I. Meetings

A. The University Senate shall hold at least four monthly meetings per academic semester, excluding the summer sessions, at a time and place indicated by the presiding officer. Additional meetings may be called at the discretion of the chair, or upon petition by one-third of the University Senate membership to the Rules Committee, which shall establish a date and place and publish the reason for such a meeting within two days of the date such a petition is received.

- B. No meeting of the University Senate shall be held when the university is not officially in session.
- C. The chair of the University Senate may convene that body during the summer session when there is necessary business to transact. For the summer session, 45 members shall be considered a quorum. Any business transaction during the summer shall be subject to the review and approval of the regular University Senate at its first scheduled meeting in the fall.

Electronic Meetings

- 1. Electronic meetings are permitted for the University Senate and its committees, at the discretion of their respective chairs, subject to the provisions of any relevant bylaw or standing rule.
- 2. Following the last scheduled University Senate meeting of the academic year, an electronic asynchronous meeting will be held to review and approve the minutes from the previous meeting. The minutes will be distributed to senators electronically. Any comments, corrections, or concerns that a senator has regarding the minutes can be expressed electronically so that all senators will receive the posting. At least two business days following the posting of the minutes, the chair of the University Senate will call for a vote and provide an electronic link where senators can vote. At least one business day will be provided for senators to vote to approve or not approve the meeting minutes. Once tallied, senators and other interested entities will be informed of the outcome.

D. Student Affairs Committee (Chair Erwin)

The Senate permitted Adam Jones (Director of the Office of Student Support and Community Standards) to address questions from the Senate. He clarified that acts of violence and Title IX violations will still be disclosed.

Rationale for Proposed Policy Amendment One

This Fall, The Office of Student Support and Community Standards (SSCS) proposes two amendments to the Community Standards Policy. The first amendment is the addition of the ability for a student to apply for their record to be non-disclosed to external entities. Part of the role of SSCS is to hold students accountable and to help them move forward from mistakes made during their undergraduate career while minimizing the impact on their future. Giving students the ability to apply for external non-disclosure helps them to take responsibility for the decisions they have made as they are required to demonstrate growth and development since the occurrence of the incident and they are required to complete all sanctions assigned to them. This minimizes the impact on their future as these incidents will not be disclosed to outside entities such as graduate schools or employers (except as required by law such as a court order or a subpoena).

Placement: Section O, page 20 of the policy

Proposed additional language:

A student may apply to have their disciplinary record marked as non-disclosable to external entities by submitting a written request to the Office of Student Support and Community Standards. In order to qualify for this designation, a student's record must not include expulsion, suspension, or any behavior that is violent in nature. Additionally, cases involving charges from the IUP Sexual Discrimination and Sexual Misconduct Policy are not eligible to be marked as non-disclosable to external entities. The student must have completed all sanction requirements and at least one calendar year must pass since the incident date of the student's most recent violation in order for the student to be eligible to apply.

The Director of Student Support and Community Standards or designee may schedule a meeting with the student applying for an external non-disclosure. The final decision will be documented in a letter from the Director of Student Support and Community Standards to the student.

If approved, the University will not disclose a student's disciplinary record to external entities except as required by law or as directed by a student via an appropriate written consent with specific instructions to the University to release the disciplinary record.

If denied, a student may re-apply to have their disciplinary record marked as non-disclosable to external entities. A student maintains the right to appeal the decision of the Director of Student Support and Community Standards to the Office of the Vice President for Student Affairs.

FOR ACTION: APPROVED

Rationale for Proposed Policy Amendment Two

The second amendment is a clarification to our sanctioning guidelines. When the Office of Student Support and Community Standards (SSCS) is determining appropriate sanctions for a situation, they are doing their best to consider the entire set of circumstances in which the violations occurred. Considering the circumstances may lead SSCS to require a more or less severe sanction than precedent might suggest based on the listed charges. This does not give SSCS the ability to be arbitrary and capricious with sanctioning, but rather allows SSCS appropriate flexibility in sanctioning, provides transparency to students that the circumstance will be considered, and allows for the consideration of discrimination-related incidents to receive more severe sanctioning. As noted in the appeals section, students will still maintain the right to appeal if they believe a sanction is arbitrary and capricious, so accountability for the decisions of the office will still exist.

Placement: Section J, page 15, the last sentence of the first paragraph

The words in red are the proposed additional language:

Sanctions are assigned to meet specific learning and developmental outcomes to assist students to understand the impact of their actions and to hold them accountable for their conduct. Sanctions are also assigned with the intent of improving upon a student's success at the University by acquiring new skills and promoting growth in various dimensions of moral and ethical development. Sanctions are determined based on aggravating and mitigating factors including, but not limited to, the following: the harm and/or potential harm which resulted from the alleged behavior; the cumulative behavioral history of the student; and/or the involvement of discrimination.

To ensure their quality and relevance, academic programs at IUP are subject to review and change by duly appointed and responsible university groups. Because of this, the university recognizes that provisions must be made to prevent hardship to students already enrolled in programs if changes later occur in specific or general program requirements. Students affected by changes in programs,

policies, and regulations are therefore given the option of following those requirements that are in effect when the student was first enrolled in the program or those in effect at the time of expected graduation. The student cannot, of course, combine chosen elements of the two. Should a question of rule interpretation arise with respect to changes, the student, the student's advisor, or both should petition the college dean for a decision about which requirements apply.

Program Changes

To ensure their quality and relevance, academic programs at IUP are subject to review and change by duly appointed and responsible university groups. Because of this, the university recognizes that provisions must be made to prevent hardship to students already enrolled in programs if changes later occur in specific or general program requirements. Students affected by changes in programs, policies, and regulations are therefore given the option of following those requirements that were in effect when the student was first enrolled in the program or those in effect at the time of expected graduation. The student cannot choose elements from both sets of requirements. Should a question of interpretation arise with respect to changes, the student, the student's advisor, or both should petition the college dean for a decision about which requirements apply.

Rationale: Reviewed as part of the five-year review process. Policy was deemed effective with minimal language updates.
