V. Items for Review/Possible Action:

- a. 11-56 ECOBIT Moratorium response: BS Business Technology Support
 - College of Business Undergraduate Curriculum Committee recommended the program be placed in moratorium.
 - Faculty affected will be moved to other departments.
 - A question arose as to where the courses currently taught in the department will be offered especially those in the Business Education degree which is not being eliminated.
 - It was decided to invite the chair of the BTST Department to address the UWUCC at our next meeting.
 - The decision was made to postpone a recommendation until after the next meeting.
- b. 11-62 B.S. Management Information Systems, program revision
 - The Liberal Studies portion of the proposal is missing.
 - Page 2, right column under controlled electives “Select two courses...” should be “Select three courses...”
 - Write out formal title for all courses as is in the catalog.
 - Need to show the full 120 hrs. for both the old and new.
 - Under part IV the assessment plan should be spelled out
 - On a Deckert/Potts motion the proposal was returned. Tickell abstained.
- c. 11-63a B.S. Accounting, program revision
 - The Liberal Studies portion of the proposal is missing.
 - Need to show the full 120 hrs. for both the old and new.
 - Under part IV the assessment plan should be spelled out
 - On a Deckert/Potts motion the proposal was returned. Tickell abstained.
- d. 11-76c RLST 250 Understanding the Bible, course revision, catalog description change
 - Make changes suggested by the Liberal Studies committee.
 - Begin second sentence of the course description “Acquaints students with...”
 - Replace ‘sh’ with ‘cr’
 - The assessment plan needs to be briefly explained for each outcome.

- Revised courses should meet the same standards as new courses when it comes to assessment.
 - Objective 3 needs to be reworded – instead of ‘pay attention to’ use ‘analyze’
 - On a Boser/Deckert motion the revision was provisionally approved pending suggested changes. There was one no vote.
- e. 11-76e RLST 250 Understanding the Bible, distance education
- Change ‘week’ to ‘module.’
 - Narrative on how objectives will be met using distance ed. technologies needs to explain better how technology will used
 - Objective 3 needs to be reworded – instead of ‘pay attention to’ use ‘analyze’
 - Define criteria for posting to the forum
 - How will student achievement be evaluated using technology?
 - In III. Distance Learning Section – make it relevant to the course; concrete actions of the students
 - Need more than powerpoint such as activity, quiz etc.
 - On a Migyank/Greenawalt motion the proposal was returned.
- f. 11-67d PSYC 360 Sensory Perception, new course
- Change Exam 4 to Final or culminating activity. Change the 1 hour to 2 hour for Exam 4.
 - Under Evaluation Methods, revise the sentence “The final component of the grade is based...” to be something more specific or quantitative to prevent grad appeals.
 - Check on the prerequisites since the companion course mentioned has another prerequisite?
 - A decision was postponed because the questionnaire section was missing.
- g. 11-82a French-College Language Requirement, catalog description change
- The table on page 2, column 3, “Either FRNC 102”, is there an ‘or’ or should “Either” be eliminated.
 - Bottom of page 2, clarify about the fee. Elsewhere it says ‘free.’
 - On a Lewis/Deckert motion the proposal was provisionally approved.
