I. Call to Order

II. On a Potts/Boser motion the minutes from October 18, 2011 Curriculum Committee Meeting were approved.

III. Co-Chairs Report:

- Welcome to a new student member, Eden Ratliff, who is majoring in Political Science and Economics.
- Sechrist reported the identification of an English Department catalog error. On page 104 in the catalog, under Bachelor of Arts–English/Writing Studies Track, ENGL 320 is listed as one of the available courses to fulfill a requirement for Studio/Portfolio/Career Preparation. There is no ENGL 320; the correct course number is ENGL 360. The correction was approved by the committee.
- Update on 11-14b Special Education- Grade 7-12 Certification, new track: Last week, the committee had concerns regarding the resources needed for the new education track. Joe Domaracki attended to address these concerns. Dr. Domaracki stated that, as stated in the proposal, current FTE are not adequate; 60 credits are currently being filled with temporary faculty. Dr. Domaracki stated that this program will have a minimal impact on what is already a program that does not have sufficient resources. The department can implement the program without adequate FTE by increasing temporary complement. The implications of delaying the implementation include the potential loss of students.

IV. The Liberal Studies Committee Report was received on a Baumler/Migyanka motion.

 - Delete reference to precedence for such program changes being set by Asian Studies program, which is not accurate
 - On a Potts/Boser motion, the track was provisionally approved.
- d. 11-33b B.S. Physics/Pre-Engineering Track, new track
 - The same issue about tracks will be addressed with this proposal.
 - On a Greenawalt/Baumler motion, the track was approved.

- e. 11-33c B.S. in Physics, program revision
 - On a Baumler/Boser motion, the program revision was approved.
- f. 11-33d B.S. Physics/Nanotechnology Manufacturing Track, new track
 - On a Vandyke/Migyanka motion, the track was approved.
