  - On a Potts/Greenawalt motion the revision was approved. Baumler abstained.

  - A discussion arose about the fact that the program still requires 123 cr. even though the Liberal Studies credits have been reduced.

  - Explain how the hours do not overlap with EDUC 242.

- ii. 11-169 EDHL 440 Professional Seminar, new course
  - Needs a culminating activity.
  - Reformat attendance policy.
  - On a Potts/Vandyke motion the course was approved. Migyanka abstained.
- jj. 11-170a EDEX 269 Identifying and Understanding Children with Academic and Social Learning Needs from Preschool through Adolescence, new course
  - Revise the Attendance Policy.
  - For the Grading Scale, add a sentence that the percent is of the total points.
  - On a Fair/Vandyke motion the course was provisionally approved. Migyanka abstained.

- kk. 11-170b EDEX 278 Identifying and Understanding Children with Significant Adaptive Behavior and Learning Needs from Birth through Adolescence, new course
  - In Grading Scale, remove asterisk after 69%.
  - On a Fair/Greenawalt motion the course was approved. Migyanka abstained.
- ll. 11-170c EDEX 424 Strategic Assessment and Instruction in Expository Text, new course
  - Grading Scale – include sentence that grade is based on percentage of points
  - Search and replace Pro-Packet with a generic course packet
  - C6 needs to be corrected.
  - On a Lewis/Fair motion the course was provisionally approved. Migyanka abstained.
- mm. 11-171 MATH 340 Principles of Secondary School Mathematics, course revision
  - Add 2 hours after Final Exam.
  - Catalog description should begin with “Provides students with mathematics content and mathematical thinking needed to teach in secondary schools, as well as to connect the content learned in college mathematics courses with the secondary curriculum. Open to secondary mathematics education majors only.”
  - On a Potts/Vandyke motion the revision was provisionally approved. Metz abstained.
- nn. 11-172a BS General Studies, program revision
  - On a Ratliff/Fair motion the revision was provisionally approved pending TECC approval.
- oo. 11-172b AA General Studies, program revision
  - On a Ratliff/Fair motion the revision was provisionally approved pending TECC approval.
- pp. 11-173 Associate in Science – Electro-Optics and Laser Engineering Technology, program revision
  - Needs appropriate signatures.
  - On a Greenawalt/Fair motion the proposal was provisionally approved
- qq. 11-44 Moratorium on B.S. in Education-Deaf Education
  - While the UWUCC understands the decision made by TECC to recommend placing the program in moratorium, the UWUCC supports TECC’s strong recommendation that faculty be hired to save the program. On a Ratliff/Deckert motion the UWUCC unanimously recommends the program not be placed in moratorium and that it be given support to hire two full-time tenure track faculty in order to make the program viable.
- rr. 11-47 Moratorium on BA Anthropology/Applied Anthropology Track
  - Based on the evidence provided to the committee, on a Fair/Deckert motion the committee does not recommend the program be placed in moratorium.
- ss. 11-47 Moratorium on BS Regional Planning/GIS and Cartographer Track
  - The program title is an old title.
  - On a Migyanka/Fair motion the committee recommends the program be placed in moratorium.
- tt. 11-47 Moratorium on BA Sociology – Applied Social Research Track
  - Will be done via an electronic vote once the co-chair hears back from the Sociology Department about their wishes for this program. The CHSS response on this program was very unclear.
  - [The Sociology Department is in favor of placing the program in moratorium since it has few students and is difficult to support. Vote in favor of placing in moratorium was 13 with one nay.]
- uu. 11-45 Moratorium on BA Biology
  - Based on the evidence provided to the committee, on a Potts/Lewis motion the committee does not recommend the program be placed in moratorium.

- vv. 11-45 Moratorium on BA Chemistry Pre-Medicine Concentration
  - Based on the evidence provided to the committee, on a Potts/Lewis motion the committee does not recommend the program be placed in moratorium.
- ww. 11-45 Moratorium on BA Chemistry
  - Based on the evidence provided to the committee, on a Potts/Lewis motion the committee does not recommend the program be placed in moratorium.
- ww. 11-45 Moratorium on BS Applied Physics – Nanotechnology
  - Based on the evidence provided to the committee, on a Fair/Ratliff motion the committee recommends the program be placed in moratorium.

  - On April 25<sup>th</sup> this program was resubmitted by the department with 120 credits.
  - An email approval vote was taken 12 members approved the revision.]
- zz. 11-124d BS—Computer Science/Languages and Systems Track, program revision
  - On May 1<sup>st</sup> it was discovered that this program that had been submitted was not on the Senate Agenda. Senate approved it as using the proposal. UWUCC voted in favor of approving the program via an email vote and 12 members approved.]
