### I. Call to Order

### II. On a Baumler/Knight motion the minutes from the August 30, 2011 University Wide Undergraduate Curriculum Committee Meeting were approved as submitted.

### III. Co-Chairs Report:

- a. Transfer Policy: Guest speakers – Michael Husenits, Director of Admissions; Bill Sands, Asst. Director of Admissions and Coordinator of Transfer Services; and Lori Roles, Asst. Director of Admissions and Coordinator of Transfer Outreach
  - A transfer policy proposal was presented. The proposal would result in students coming to IUP with an Associate's degree having their general Liberal Studies credits fulfilled. Students, however, would still have to take any program or college specific LS courses that they had not yet taken. The proposal particularly targets students coming in with an AA or AS degree. Projections show a decrease in high school graduates in counties where students typically attend IUP. Transfer students with an associate's degree typically have higher GPA's and a higher graduation rate than freshmen or other transfer students. The policy would work with PA Community Colleges. CC's from other states would be handled on a case by case basis.
  - The group in general agreed with the proposal but would like to see the policy in writing.
- b. Handbook Revisions: Table of contents, Liberal Studies Checklist (p. 33), and a few other items had minor changes.
