 - In the course description change the last sentence to Also identifies..... Also... there are too many ands in the first sentence.
 - Check on first three objectives to make them more related to media.
 - Change two to three journal entries in evaluation section.
 - In the second paragraph for the Rationale for Outcome 1, the second sentence Change to "It presents . . . in Asian countries such as . . ."
 - On a Lewis/Knight motion, the proposal was provisionally approved. Muchtar abstained.

 - Change D2 to D2L on page 1.
 - Update corrected objectives from face-to-face proposal.
 - Check year of textbook in bibliography.
