I. Call to Order

II. Co-Chairs Report:

Regarding the ANTH 27X courses that had been crosslisted with Sociology, the chair of the Anthropology Department said that there have not been any SOC seats offered since the two departments split and that the ANTH Department did not wish to continue to have them crosslisted.

The ANTH Latin America Area course was not crosslisted with LAS and that needs changed in the minutes, the ANTH 370 that is crosslisted with LAS was shared with the LAS coordinator and it is being checked to see if the original proposal can reflect that before going to Senate.

The Co-chair had a meeting with staff in the provost's office to discuss the issue of the crosslisted Financial Wellness DE courses that the committee had reviewed. In looking back at previous similar courses approved for DE (Computer Literacy) it was shown that each department submitted a separate DE proposal. This ensures that each individual faculty member receives the full development fee. So the FCSE program was informed that they did need to submit a separate proposal to offer FCSE 143 DE; the department did not plan to offer it via DE until the summer so will submit a proposal later. Additionally it was pointed out that the registrar's office does not consider this type of course as crosslisted, perhaps a different term such as corollary courses should be used for the type of courses that have different departments teaching them vs. the type that have one instructor whose students might have two different prefixes.

The first meeting of the UPC Academic Excellence Committee was held on Monday. The committee mainly discussed its role and issues it might deal with but had no major discussion on revising the UWUCC approval process. David LaPorte's suggested changes will be shared with UWUCC.
