#### I. Call to Order

On a Killam/Freda motion, the minutes from April 12<sup>th</sup> were approved as corrected.

- The Co-chair explained some of the changes to the minutes based on items that were noticed as the Senate Agenda was being created.

#### IV. Items for Review/Possible Action:

- 15-152 PHYS 260 Introduction to Nanoscience and Technology, distance education
  - Proposal still does not address how objectives will be accomplished via distance education specifically enough.
  - On a Wachter/Greenawalt motion, the proposal was provisionally approved. Freda abstained.
- 15-91e Revision to the Music Minor Footnote
  - On a Killam/Deckert motion, the proposal was approved. Clewell abstained.
- 15-136 Minor in Community Health, new minor
  - Title for 431 needs full title.
  - Consider adding one footnote: Use of only one prefix for elective courses? Students could take all three in SOC. (Max of 2 courses?)  
[Proposer agreed to adding a footnote by the Electives: (1) Only two courses with the same prefix may be used as electives.]
  - On a Greenawalt/Wachter motion, the proposal was provisionally approved. Racchini abstained.
- 15-137 Minor in Mathematics, program revision, catalog description change
  - Use of either when it seems that among would fit better in electives statement needs to be clarified.
  - Should there be a range of total credits since some classes have 4 credits.  
[Proposer replied that this is covered in the range for the other courses.]
  - Does footnote 2 need to be no more than 6 credits can overlap with the Applied Stats Minor?  
[Mocek agreed that this should be no more than 6crs not 9crs. of overlap]

- r. 15-146k COMM 403 Broadcast Newswriting, modify prerequisites, catalog description change
  - Are is missing in rational and add rationale about why deleting instructor.
  - Semicolon in prerequisite.
  - On an Ali/Deckert motion, the proposal was provisionally approved.
- s. 15-147 COSC 355 Computer Graphics, course revision, catalog description change, modify prerequisites
  - On a Freda/Deckert motion, the proposal was approved.
- t. 15-150 GEOS 492 Soils and Soil Geochemistry, catalog description change, course number change (was 313), modify prerequisites
  - If catalog description is different for the cross-listed course, how can they be cross-listed?
  - Suggest using as a substitution not cross-listed. Is this reciprocal both ways? We need to ask Anthropology too? If it is not to be crosslisted, we will need to go back and correct previously approved one.

[Geoscience replied that it is intended to be crosslisting and that it is reciprocal in both directions, he said that it was fine to use the ANTH soils course catalog description for the GEOS version of the course.]
