I. Call to Order

III. Co-Chairs Report

Yesterday the Co-chairs of the Graduate Committee and the UWUCC met with Mocek and Eric from IT about modifications to adapt to the new online system. Only when there are major changes to a proposal will the proposal be returned to the beginning of the approval process. The proposers will now be given editorial rights when it reaches the UWUCC level so that they can correct relatively minor wording changes. The co-chairs also have editorial rights to correct typos and other minor changes (while informing the proposer). There will be a dashboard where the committees can tell the proposers what tasks they need to perform. The proposal will be pending or provisional until the changes are made and then after the committees verify that the corrections have been made then they would be marked as approved.

 - 2nd and 3rd sentences of the catalog description need verbs at the beginning. Compares patterns and Studies relationships
