- I. Call to Order
 - Meeting started at 3:30pm
- II. Approve minutes from March 9, 2021 with all of the corrections included in the last revised version.
 - --Approved on a Greenawalt/Black Motion
- III. Co-Chair's Report
 - --Welcomed our new student committee member Michcayla Schambura. Co-Chair Sechrist also discussed changes to the minutes from our 3/9 meeting.
- IV. Liberal Studies Report
 - -- Liberal Studies report is included throughout the minutes as noted under appropriate proposals.
- V. Items for Consideration and Possible Approval
- a. 20-230 ANTH 272 Culture Area: China, distance education
 - -- There should be a ":" in-between "Area and China in the title. The instructor needs to provide a further description of their qualifications in Anthropology.
 - -- Provisionally Approved on a Black/Fair Motion
- b. 20-227 CHSS 482 Big Ideas Internship, new course
 - -- The number 482 is designed for "independent studies." Most internship courses use the number 493. The certificate is listed as 15 credits, however, with the variable credit option (1-3) would potentially affect the total.
 - -- There is a concern about the use of the word "internship" in the title due to the non-traditional nature of this experience vs. a traditional internship in a corporate (or other) setting under supervision. A title of "capstone" may be a better fit. The title has the word Capstone in the Certificate proposal.
 - -- In the prerequisite the word minor should be certificate
 - -- In the second outcome line the first two words are run together.
 - -- Return on a Greenawalt/Ali Motion
- c. 20-221 Big Ideas: Transformative Culture and the Professions Certificate, new certificate
 - -- Remove the ":" between all the course numbers and the first word of the title; it should be a free standing "-"
 - -- All prerequisite courses should be removed (not able to be listed in catalog).

- -- There is a lot of overlap between the different tracks as well as with the first large group of courses.
- -- Would it be possible for a student to complete multiple tracks?
- -- Also, because of the multiple discipline areas involved, there may be a challenge for the capstone class to tie everything together.
- -- There were questions about the purpose of the certificate and can it meet those goals with such a long list of possible combinations that could be taken.
- -- There is a concern surrounding the very long list of courses and the congruency/ connection between them. It is recommended that the list of courses be reduced.
- -- Postponed and requested that a Big Idea's committee member attend a future meeting to address the committee's concerns.
- d. 20-224 K-12 Teacher Education Track, Health and Physical Education, BSED, program revision
 - -- Approved on a Minnick/Ali Motion (Katchmarchi Abstained)
- e. 20-225a CDFR 425 Adolescence: Risk and Resiliency, catalog description change, modification of prerequisites, course revision
 - -- In the course description, the second sentence could start with "Emphasizes identifying risk . . .".

- f. 20-225b CDFR 323 Family Issues, catalog description change, course revision
 - -- Second sentence should begin with the word "Reviews" and remove the "are also reviewed" at the end.
 - -- Missing the last column in the SLO Category.

 - -- Approved on a Fair/Lewis Motion

- i. 20-226c ECON 434 Managerial Economics, modification of prerequisites, course number change (was 334)
