- II. Minutes approved from 1/31 Minutes were approved unanimously on a Greenawalt/Ford Motion

Before the meeting started members welcomed our third student member of the committee, Callie Bland.

Issues with Sociology/General Sociology Track, BA and Sociology/Human Services Track, BA

The Department Chair contacted the Co-chair because of a concern her Dean had raised with the program. The dean was examining the last side-by-side in the iwiki which did not include the language requirement. The department had no intention of deleting their language. The side by side presented to APSCUF in April of 2023, however, did include the language requirement. After talking with the chair a check of the electronic catalog revealed that the language requirement was there except that it had been shifted from LS Electives to be right before free electives. The editor though did not revise the footnote numbers after changing the order of items. They also removed the double listing of SOC 151/161. Reilly pointed out that this was due to the new System policy that does not allow double listing of requirements. Again a footnote that then should have been removed was still in the program. In the Human Services Track the word required was after the word Mathematics even though the next line says MATH 217 recommended. Lastly it was found that the free elective numbers that were in the catalog or were in the APSCUF approved version did not add up correctly. Members double checked the numbers and so a corrected version will be sent to APSCUF in March to fix the footnote, math requirement, and credit number issues.
