Implications for other programs are negligible. Courses in genetics and analytical chemistry are corrected to their current designation and title. Inactive courses (BIOL 350 and 453) are removed from the list of other requirements. Implications for students will be to reduce confusion about requirements for a minor in biochemistry.
