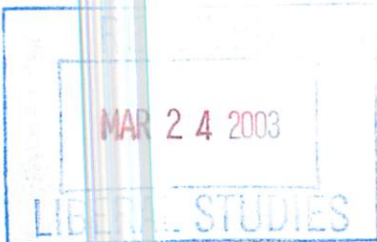

Part II. Description of the Curriculum Change

1. An exact statement of what is to be deleted.

The course listing BIOL 322 Environmental Protection II is to be deleted.

2. Justification/Rationale

BIOL 322 Environmental Protection II is being revised and its revision includes a course prefix, number, and name change to ENVH 222 Environmental Health and Protection II. Therefore, BIOL 322 Environmental Protection II should be deleted to make this prefix and number available for a future new biology course.

3. Revision of BIOL 322 Environmental Protection I to ENVH 222 Environmental Health and Protection II is part of an Environmental Health Program Curriculum Revision Proposal; designed to update the Program and to make it suitable for accreditation by the National Environmental Health Science and Protection Accreditation Council. BIOL 322 is a currently a required course for Environmental Health majors, and a controlled elective for Environmental Geoscience majors. They will be able to take ENVH 222 in lieu of BIOL 322.
