We have agreed to accept JRNL 105 for COMM 101 if students have already taken that course. Currently students who have taken JRNL 105 must request an override for any course for which COMM 101 is a prerequisite. This change will resolve that issue for students.</p> <p>Additionally, the prerequisites are changed to manage course enrollment and limit enrollment to specific groups. This is an introductory production course with limited lab capacity and seat availability. With recent additions of certificate programs that require this course or specify it as an elective, restrictions on enrollment are necessary. Other students may be enrolled with permission based on seat availability.</p>
