Dear Dr. Steiner:

I have been notified of the proposed changes in the curriculum of your department to merge your two majors; Dietetics, and Food and Nutrition Science into one new undergraduate major; Nutrition.

If I understand your proposal correctly, all students in your department would be in one or the other of your two proposed Natural Science tracks, I and II. Track I includes all three biology courses currently required of Dietetics majors (BI-105, BI-155 and BI-232) and Track II includes all three biology courses currently required of Food and Nutrition Science majors (BI-150, BI-151 and BI-232) with the addition of BI-105.

Since all of your majors would still be required to take the same courses they do now, especially BI-232, I do not see that your proposed revision should change our course enrollments at all. I should note, however, that if your majors continue to be the only ones taking BI-232, as has been the case the past year, we may only be able to offer it one semester per year and will probably not be able to offer it in the summer (as we have not this summer and last).

In light of the above, I support your proposed change in your curriculum.

It is so nice to hear from you. I feel honored to be invited to serve on your advisory committee. I recieved the letter you sent on 2/26 and had several ideas about the proposed changes.

I am very interested in the concept of a self-study undergraduate didactic Program in Dietitics and would like too hear more about this.

I am happy to hear that the Dietetics program at IUP remains strong and I can recall that the Food and Nutrition program was small when I attended IUP. I am sad to hear that over 50% of the dietetic graduates do not become registered dietitians, but I understand that there are several barriers that these graduates face in pursuing internships and registration. the opportunity to interact with several IUP grads who did not pursue registration or did so at a later time and have learned a great deal from them about the difficult job market for undergraduate nutrition majors. think it is a great idea to combine the dietetics and Food & Nutrition Science Programs. I think it is important to provide the science track option for those students that at some point may want to pursue further education in Food Science, Research or other medical/science related areas that would require these science prerequisites. I also think it is important for students who do not intent to pursue their RD that they have a minor or specific training which will provide them an edge in today's competitive job market. I think there are opportunities for non-RD nutrition majors out there but students need to have expertise or knowledge about specific opportunities in these areas in order to find jobs. I think the Program Minors in Chemistry, Communications, Gerontology, Hotel/Restaurant Mang., Natural Sciences, Psycology and Pys. Ed. are areas that these students could find opportunities in. Lastly, I feel the current Dietetic Curriculum is execellent and provided me with the training I needed to pursue a Master's in Nutrition and an RD.

Hello and thanks for asking....

- 1. Is the concept of selecting a science track by the student advisable?
- Absolutely. Science seems to be the stumbling block for students with an interest in food or a nutrition major (as a stepping stone) but not necessarily in the end product of dietetics.
- 2. What is you opinion of the development of core concentrations or minors for the non-DPD major in the nutrition track? The options leave open the door for going back and picking up the DPD (with the necessary additions) or at least give a basic underpining for the type of student who in the past was happy with a didactic degree. For those interested in the core as stepping stone for advanced study or branching into some related area, there is still the appreciation of the science and theory that is basic to dietetics.
- 3./4 Are there other subject areas that should be included in the core concentrations?
- At this point you have given room for options. There is always need for other subject areas but I couldn't suggest what to cut. Education, communications and marketing are areas that can always be enhanced as skills necessary for the job market. It would seem that you will need to see what the interests are of those you attract before you add to the core or the requirements to the point that you have limited choices to make it too close to dietetics.
- 6. As I mentioned, we are not proposing curriculum changes for the dietetics program at this time, but will be reviewing our current offerings in comparison to the Current ADA Standards of Education. Are there areas that you would recommend for us to review and consider? Yes....communications. Written and oral communications, use of technology for communications purposes are survival skills that entry level dietitians don't get unless they have simulations or practice in their undergraduates.
