Part II. Description of the Curriculum Change

1. An exact statement of what is to be deleted

The Course GRMN 101 Elementary German (var 6cr) is to be deleted.

2. Justification/Rationale

There are two reasons for the deletion of GRMN 101:

- a) GRMN 101 is an active course that has not been taught since Fall 2001. There is no student demand for it. This is an accelerated Elementary German course combining German I and II.
- b) The German section of the Department of Foreign Languages is redesigning the Elementary and Intermediate language sequence to follow the model of the Spanish section. Three 4-credit courses will replace the current four 3-credit courses. French and Chinese are also going to this model. To align the format across languages, the 101 course number is needed to designate the first course of the new sequence.
- 3. A description of how this change will affect existing courses, programs, etc. and how the deletion(s) will affect students currently enrolled in the program

This change will not affect other programs. This deletion allows for the use of 101 for a new 4-credit GRMN 101.
