7. An exact statement of what is to be deleted

The Course GRMN 201 Intermediate German (var 6cr) is to be deleted.

8. Justification/Rationale

There are two reasons for the deletion of GRMN 201:

- e) GRMN 201 is an inactive course that has not been taught since Spring 2001. There is no student demand for it. This is an accelerated Intermediate German course combining German III and IV.
- f) The German section of the Department of Foreign Languages is redesigning the Elementary and Intermediate language sequence to follow the model of the Spanish section. Three 4-credit courses will replace the current four 3-credit courses. French and Chinese are also going to this model. To align the format across languages, the 201 course number is needed to designate the last course of the new sequence.
