Part II. Description of Curriculum Change

1. Current Catalog Description:

SPAN 220 Intermediate Spanish Conversation

(3c-0l-3cr)

Prerequisites: SPAN 201 or equivalent

Intensive work on oral communication skills with emphasis on spontaneous interpersonal speaking, discourse strategies, vocabulary building, and pronunciation. Required for all majors and minors. (Offered as SPAN 221 prior to 2004-05)

2. Proposed Change

SPAN 220 Intermediate Spanish Conversation

(3c-0l-3cr)

Prerequisites: SPAN 201 or equivalent

Intensive work on oral communication skills with emphasis on spontaneous interpersonal speaking, discourse strategies, vocabulary building, and pronunciation. Required for all majors and minors. No student will be allowed to register for or take a D/F repeat in SPAN 220 when credit has already been received for a higher numbered Spanish course. (Offered as SPAN 221 prior to 2004-05).

3. Rationale for Change

The addition of the clause prevents students (particularly native and heritage speakers) from taking SPAN 220 when they have already received credit for SPAN 350 or 450, which are conversation courses of a higher level. SPAN 101, 102, and 201 have a similar restricting clause, and this proposed change would put SPAN 220 in line with them.
