COURSE SYLLABUS

I. CATALOG DESCRIPTION

Spanish 412 The Spanish Novel of the Nineteenth and Twentieth Centuries 3c-01-3sh

Prerequisite: "C" grade or better in Sp 260 or permission

Analysis of selected novels from three major periods: the nineteenth century, the Generation of 1898 and the post Civil War.

II. COURSE OBJECTIVES

The Spanish Novel is taught in Spanish and is designed as an introduction to the genre of the novel in Spain.

- 1. Students will read and analyze six novels representative of three important periods in the development of the Spanish novel: the nineteenth century, the Generation of 1898, and the post Civil War.
- 2. Students will also acquire knowledge ofthe historical/social/political situations important to the development of the Spanish novel and the contributions of other significant Spanish novelists.
- 3. Students will participate orally in class discussions.
- 4. Students will participate in writing in Spanish in the following manner:
- a. They will write three short (one to two typewritten pages) reaction papers on a topic provided by the instructor. There will be six topics given, one for each novel; each student may choose any three during the semester.
- b. They will write a six to ten page research paper typed according to the MLA style. The topic will be some aspect (chosen by the student and approved by the instructor) of one or more of the novels studied.
