II. Track Change: Bachelor of Science - Regional Planning/Land Use Planning and Geographic Information Systems Concentration

1. Catalogue Description: Regional Planning/Land Use Planning and Geographic Information Systems Concentration

The land use planning and geographic information systems concentration prepares students for employment as professional planners adept at applying advanced techniques to the development of livable communities. Data collection, spatial information management, and graphic presentation are integral skills taught in the program. Course work also equips students for facilities planning and management, remote sensing applications in planning, and site location analysis. Course work includes methods for identifying, modeling, and analyzing the spatial organization of community systems from both practical and theoretical perspectives. Students in planning graduate with a working knowledge of subdivision, land use, and zoning regulation. They are familiar with strategies of economic development. They understand both the theory and ethics of planning. Students completing this track should be able to assist diverse communities and organizations in identifying and finding solutions to a wide variety of land use, siting, and transportation problems.

Addition of RGPL 103 Global Cities as a required course for the Social Science liberal studies requirement for the Regional Planning major.

Addition of RGPL 203 Planning History as a required core course for the Regional Planning major. Addition of RGPL 462 Planning Policy, Implementation and Administration as a required core course for the Regional Planning major.

Deletion of RGPL 464 Land Use Policy as a required core course for the Regional Planning major. Deletion of PLSC 376 Public Sector Budgeting and Financial Management as a concentration course. Addition of RGPL 332 Urban Geography as a Regional Planning – Land Use/GIS concentration course.

Addition of RGPL 404 Transportation Planning as a Regional Planning – Land Use/GIS concentration course.

3. Rationale for changes.

During the fall of 2012, a site visit team (SVT) from the Planning Accreditation Board (PAB) visited the Department of Geography & Regional Planning as part of the accreditation evaluation of the Department's Bachelor of Science in Regional Planning program. Although the program received an overwhelmingly positive review, the SVT did have some specific recommendations regarding curriculum and utilization of resources.

In terms of curriculum, the team felt that there needed to be a course that newly-declared majors could enter that would provide them with a focused introduction to the origins, history and traditions of the planning discipline. We have added RGPL 203 Planning History to the Regional Planning core to address these issues. The SVT also suggested that planning administration and implementation needed to be explicitly dealt with in a core program course, so we have proposed RGPL 462 Planning Policy, Implementation and Administration as a required core course for the Regional Planning major (replacing RGPL 464 Land Use Policy). In adding these courses, we needed to remove a course from the Regional Planning core to stay with the 120 credit PASSHE degree requirement, so RGPL 332 Urban Geography has been moved from the core to an option in the GIS/Land Use Planning concentration. RGPL 404 Transportation Planning has been added as an option to the GIS/Land Use Planning concentration, since the course did not exist at the time of our last program revision. PLSC 376 Public Sector Budgeting and Financial Management is being deleted as a track course because the course has not been offered in a number of years and is no longer in the current catalog.

Finally, GEOG/RGPL 103 Global Cities has been added as a Liberal Studies Social Science requirement for the Regional Planning program. The major reason for this change is that the SVT refused to give us credit towards faculty FTEs in the Regional Planning program for RGPL 103 during our last review, because they said that the course was not a curricular requirement for the program. This was problematic, as it caused our program faculty FTEs to be calculated at under 5 (4.25), which is a benchmark in PAB accreditation documents. The Regional Planning faculty decided to respond to the SVT's interpretation of the FTE calculation by making RGPL 103 an LS Social Science requirement for the program, which will immediately increase our FTE calculation to 6.28 (based on the 2013-2014 academic year).

III. Implementation

- 1. Students already in the program or entering this year will be given the option of finishing under the present requirements. All new students new to the program in 2014-15 will be expected to follow the new curriculum.
- 2. Faculty resources are adequate, as new faculty have been hired over the last two years who will teach the proposed courses.
- 3. The enrollment in the Regional Planning program has more than tripled over the last seven years. We are projecting continued growth based on the program's strong position of being one of only 15 accredited undergraduate planning degree programs in the United States.

IV. Periodic Assessment

The Department of Geography and Regional Planning engages in constant quality improvement.
 In addition to the 5-year planning cycle mandated by the University, we hold annual retreats to
 review enrollment, curriculum, and external context. The curricular changes proposed here are
 the result of an external evaluation completed during the Fall of 2012. Accreditation mandates
 ongoing internal evaluation and 5-year external reviews. Criteria are complex, but include:
 student interviews, an advisory board of program graduates that meets annually, consulting with

- professional planners, and measuring the program against national curricular and performance standards.
- 2. Internal evaluations are on-going with annual reports. External evaluations are every 5 years.
- 3. Internally the Planning Program faculty and the Planning Advisory Board made up of professional planners review the program annually.
