Part II. Description of Curriculum Change

To minor in History, 15 credits of courses with a HIST prefix are required, with at least 3 credits taken at the 300+ level. At least 9 credits must be completed at IUP.

2. Summary of changes:

3. Rationale for Change.

Requiring at least 3 credits at the 300+ level

Requiring students to complete at least one upper-division course gives them a more indepth study of a particular topic than a broader lower-division survey can provide.

Completion of 9 credits at IUP.

The History Department believes that in order to get a minor, students should complete at least two-thirds of their credits in the Department. According to the undergraduate catalog the English Department currently has a policy of not accepting more than 6 transfer credits for the minor.

1. How will the proposed revision affect students already in the existing program?

The proposed revision will not affect students who have already declared a minor. It will only affect those who declare a History minor once the program revision goes into effect.

2. Are faculty resources adequate? If you are not requesting or have not been authorized to hire additional faculty, demonstrate how this course will fit into the schedule(s) of current faculty.

Yes. The proposed revisions should have minimal impact on faculty resources since most minors already complete several courses at IUP. The upper-division (300+) courses open to non-majors are capable of absorbing more students.

3. Are other resources adequate? (Space, equipment, supplies, travel funds)

Yes. Other resources will be as adequate for the proposed program as for the existing program.

4. Do you expect an increase or decrease in the number of students as a result of these revisions? If so, how will the department adjust?

We anticipate no significant change in overall student numbers.
