Rationale for the change

HIST 321 has not been offered for many years and is no longer in the catalog. HIST 320 is only offered occasionally, and as a result the department has to accommodate all the Pre-Law students in HIST 346. By expanding the number of classes that count for Pre-Law it will be easier for students to schedule and it will be easier for the department to deal with the demand. It will also make it possible for students to choose to focus on different aspects of the American legal tradition as part of their studies.

While most U.S. History classes deal with legal and constitutional issues it seems to the department that these are the courses that are most likely to be valuable for Pre-Law Students. All of these have been used by the department as substitutions for the Pre-Law requirement on a case by case basis.
