1. LIBERAL STUDIES COMPONENT

- a. Remove CHEM 101 and CHEM 102 as the specific Natural Science Requirement.
- b. Include CNSV 315 as a required Liberal Studies elective.

3. Justification/Rationale for Revision

B. List of associated changes

1. LIBERAL STUDIES COMPONENT

- a. Students in the CDFR field do not have a professional need for CHEM 101 & 102. Many students change their majors into the CDFR program having already completed their Liberal Studies science courses. Any Liberal Studies approved science sequence is acceptable/beneficial in the CDFR field.
- b. CNSV 315 Consumer Economics and Family Finance has been counted as a major course. It is a liberal studies approved elective and is more accurately included in that part of the curriculum. This will make no change in the expected enrollment of this course.

2. MAJOR COMPONENT

a. Tracks B and C have never been fully operational and all students have been advised to complete track A.

Track A is the strongest professional track and prepares students to work with both children and families in a wide variety of human service agencies. There are no students in either track B or track C. CDFR 420 will be added to free electives in the major. CDFR 493 is a free elective.

b. FDNT 212 Nutrition has a prerequisite of CHEM 102.

Many of the CDFR students who change their majors into this field do not have Chemistry as their science. This course will be replaced by FDNT 145 Introduction to Nutrition.

3. OTHER REQUIREMENTS: OUTSIDE COURSES

- Add FDNT 145 Introduction to Nutrition. The FDNT Department Chair concurs that this course is more appropriate for CDFR majors.
- b. CDFR majors are not entering professions in the teacher certification area. Academic content of EDSP 102 is not required by any CDFR professional field approval organizations. Removal of this course from the requirements will allow CDFR students greater flexibility in the selection of courses and will provide them with greater opportunities to do internships and complete minors in related fields.
- c. CDFR majors typically have the basic technology skills required for the successful completion of our major courses and to take into the professional field of working with children and families. Removal of COMM 103 from the requirements will allow CDFR students greater flexibility in the selection of courses and will provide them with greater opportunities to do internships and complete minors in related fields.
- d. NURS 202 contains content that familiarizes students with basic anatomy and physiology of children and includes a specific focus on children's health issues. It will provide more flexibility for CDFR students in scheduling and is a reasonable alternative to BIOL 155.

4. FREE ELECTIVES

a. The increased number of free electives will allow students to more easily complete the elective courses and the internship necessary to be eligible for the Certified Family Life Educator Certificate from the National Council on Family Relations or the Child Life Professional Certification It will also allow the additional completion of a minor in a related field.

Part III. Implementation

1. How will the proposed revision affect students already in the existing program?

All students are currently enrolled in track A which will be included in the major course requirements. There are no students currently in either track B or track C. All other program changes can be handled through the advising process. No student will be disadvantaged by these changes.

2. Are faculty resources adequate?

None of the proposed changes will impact the faculty load in the program. No courses taught in the program have been added or removed.

3. Are other resources adequate? (Space, equipment, supplies, travel funds)

None of the proposed changes impact resources already available to the program.

4. Do you expect an increase or decrease in the number of students as a result of these revisions? If so, how will the department adjust?

We do not expect these revisions to result in any change to the number of students in the program.

Part IV. Periodic Assessment

1. Describe the evaluation plan. Include evaluation criteria. Specify how student input will be incorporated into the evaluation process.

The CDFR program review is included in the Five Year Department Evaluation as required by SSHE. As a part of that process, questionnaires are sent to graduates and students are surveyed. The National Council on Family Relations also reviews the program as part of the approval process needed in order for students to be eligible to receive the provisional Certified Family Life Educator certificate upon graduation. This program approval must also be renewed every five years.

2. Specify the frequency of the evaluations.

The program is reviewed every five years.



Hello Mary Ann, The Child Development and Family Relations Curriculum Committee has been working on a program revision for the CDFR major. The committee is recommending that the EDSP 102 Educational Psychology course no longer be required for students in our major. The CDFR courses already include content related to learning and cognitive development that is specific to the out-of-school settings where our students typically work. Our students are not certified to teach in the educational institutions that are the focus of the EDSP 102 course. We hope that our students would be able to continue to take this class as an elective. Our students need the additional flexibility within free electives to take a minor, to complete special non-teaching certificate requirements in child and family areas, and to complete internships.
