Part II. Description of the Curriculum Change for CNSV 482 Independent Study

1. An exact statement of what is to be deleted.

CNSV 482 Independent Study

var-1-3cr

Prerequisite: Prior approval through advisor, faculty member, department chairperson, dean, and Provost's Office

Particular consumer considerations are independently investigated in the area of housing, home equipment, interior design, clothing, and textiles or in the management of resources. Course may be repeated for a total of 3cr. Students meet with a faculty member at least 5 hours per credit.

2. Justification/Rationale

The Consumer Services program/degree has been eliminated, and courses with the CNSV prefix are being submitted for a prefix change to FCSE. FCSE 482 Independent Study already exists. There are no students in the CNSV program who would be affected by the deletion of this course.

3. A description of how this change will affect existing courses, programs, etc. and how the deletion(s) will affect students currently enrolled in the program.

CNSV 482 is not a prerequisite for any course and deleting the course will not affect other courses or programs. The CNSV program was eliminated, so no students would be affected by the deletion of this course.
