I. Catalog Description

NURS 469 Community Health Practicum

0 lecture hours 6 lab hours 2 semester hours (0c-6l-2sh)

Prerequisites: NURS 334

Prerequisite or Corequisite: NURS 434

This course allows the Registered Nurse to apply knowledge to the practice of community-based and community health nursing. Emphasis is placed on health promotion, risk reduction, and disease prevention in a wide variety of community settings and with diverse populations.

II. Course Objectives:

At the completion of this course the student will be able to:

- 1. Utilize the nursing process to provide and promote health for individuals, families, groups and populations.
- 2. Differentiate the multiple roles of community health nurses.
- 3. Demonstrate proficiency as a member of the profession and as provider and coordinator of healthcare in a variety of community settings.
- 4. Identify researchable clinical problems applicable to community health nursing practice.
- 5. Adhere to professional standards and codes.
- 6. Facilitate the use of available resources to meet varying degrees of health care needs of individuals, families, groups and populations.

III. Course Outline

Course Overview

Given the academic background and previous work experience of the student, the RN selects appropriate community sites for professional practice experiences. Students will need to seek faculty approval of clinical site selection. The experiences are designed to provide opportunities for role development and increased competencies in the provision of nursing care to communities-asclients and to community-based programs for individuals, families, groups and populations. The RN student will be given the opportunity to develop a

community health practicum that will enhance individual needs for professional growth. The student is responsible for 84 hours of community practicum experience over the semester that will include regular clinical conferences with the faculty.

The clinical course is divided into 2 units. Unit I emphasizes the community-asclient. This unit introduces students to population-focused approaches that are unique to Community Health Nursing. Unit II emphasizes community-based nursing care.

UNIT I: Community as Client

(40 hours)

Orientation to community clinical, overview of expected competencies and agency orientation requirements

Students will have learning opportunities and clinical experiences related to the provider of care role of community-as-client. Activities may include: community assessment, epidemiological evaluation of morbidity and mortality rates in a community, community planning and intervention (based on a needs assessment), community evaluation of existing programs, evaluation of plans for disasters, and a population-focused teaching plan aimed at primary and secondary prevention/intervention

UNIT II: Community-Based Nursing Care

(41 hours)

Orientation to community-based nursing agency, overview of expected competencies for Unit II

Students will have learning opportunities and clinical experiences related to the provider of care role in community-based clinical practices. Activities may include: health promotion, risk reduction, and disease prevention, teaching/learning needs of diverse populations-at-risk, multidisciplinary collaboration, and aggregate-focused teaching plan for a population-at-risk

Course Conclusion

(3 hours)

Summary, evaluation of learning outcomes and student evaluations

IV. Evaluation Methods

The final grade for this course will be determined as follows:

Mini portfolio

50%

Based upon guidelines provided to the student a mini portfolio will be completed. The mini-portfolio will include a community assessment, epidemiological evaluation of health in the community, community intervention plan, population-focused teaching plan, aggregate-focused teaching plan, and a comparison of community clinical settings paper.

Summative clinical evaluation 50%

The clinical evaluation will be based upon faculty review and input from the clinical site.

COURSE ANALYSIS QUESTIONNAIRE NURS 469: Community Practicum

Section A: Details of the Course

- A1 This course is a required course for all registered nurse students enrolled in the Bachelor of Science degree in Nursing program, registered nurse track.
- A2 This course is part of a new track for registered nurses.
- A3 This course has never been offered at IUP.
- A4 This course is not intended to be offered as a dual-level course.
- A5 This course is not intended to be taken for variable credit.
- A6 Many baccalaureate nursing programs for Registered Nurses require a course such as this. Examples of such programs include: University of Central Florida, NUR 4636L; Southern Connecticut State University, NUR 463 and NUR 465; Widener University, NUR 456; The Pennsylvania State University, NUR 415; and LaSalle University, Nursing 413.
- A7 The content in this course is a necessary component of professional nursing practice as recommended by the American Association of Colleges of Nursing. Additionally, a major report from the Pew Health Professions Commission recommends higher degree nursing programs increasing learning experiences in community-based settings. (See attached documentation).

Section B: Interdisciplinary Implications

- B1 Each section of this course will be taught by one faculty member within the Nursing Department.
- B2 This course does not overlap with any other courses at the University.
- B3 Two seats will be available for Continuing Education students who meet course pre-requisites.

Section C: Implementation

- C1 No new faculty are needed to teach this course. See faculty resource section of proposal.
- C2 Other resources
 - a. Current space allocations and clinical site affiliations are adequate to offer this course.
 - b. Currently Stapleton Library subscribes to a number of nursing journals that would be helpful for students in this course. These journals include: Public Health Nursing, Family and Community Health, Nursing and Health Care: Perspectives on Community, Home Healthcare Nurse. In addition, the Department of Nursing and Allied Health Professions receives subscriptions to other journals that might be useful to students in this course. These journals include: Research in Nursing and Health, Journal of Professional Nursing, and Image: Journal of Nursing Scholarship. The library has a satisfactory holding of references related to nursing and the Internet provides additional reference materials for students. Periodic updates of library holdings are necessary. The department has a mechanism in place for identifying and recommending future purchase for library holdings.
- C3 No grant funds are associated with this course.
- C4 This course will be offered every Spring semester
- C5 One section of the course will be offered at a time.
- C6 Fifteen students will be accommodated in each section. Class size is influenced by faculty requirements to supervise the clinical component of this course.
- C7 No professional society limits enrollments in a course of this nature.
