



- Born Mid 1990s-2015
- True Digital Integrators 41% spend 3 or more hours/day in front of screens (at least 3-5 at a time); prefer to gather knowledge by watching videos on social media; less likely to read articles or books; prefer non-verbal communication
- Fiscally conservative; 68% have student debt
- Higher diagnosis of ADHD; attention spans falling from 12 seconds to 6-8 seconds
- Driven by motivation; do not want to let people down
- Advocate for social justice
- Affected by threats of terrorism in an uncertain world
- Biggest fear is not finding career that matches personality








